
1,989 comments received via email and mail;

# Cougar Sport Harvest Limits

- No proposed changes to sport harvest limits from the current rule
- Harvest limits are not met in approximately 85% of Cougar Management Zones

# Cougar: Proposal

# Manner and Method Requirements and Restrictions 19.31.11.10 NMAC

 Eliminate the need for private landowners to obtain a permit prior to using traps or foot snares for sport harvest.

 Allow traps and foot snares as a legal method of sport harvest on private and State Trust lands from Nov – March.

# Manner and Method Requirements and Restrictions 19.31.11.10 NMAC


- Allow increased bag limits in Zones where harvest limits are not being reached.
- Prohibit use of hounds during September deer and elk archery seasons
- Allow licensed deer and elk hunters to hunt cougars on certain WMAs during their hunt






#### Habitat Model

Primary habitat = 54,793 km<sup>2</sup> (18% of NM)






**NW Area**


**NE Area**


**SW Area**




