Quota Statute

17-3-16 (NMSA 1978)

Licenses shall be issued as follows:

- **10% of the licenses to nonresidents and residents who contract with an outfitter; and**
- **6% of the licenses to nonresidents not contracted with an outfitter; and**
- **A minimum of 84% to residents of New Mexico.**



Quota Statute

17-3-16 (NMSA 1978)

If applying the percentages yields a fraction of:

- **Five-tenths or greater, the number of licenses to be issued shall be rounded up to the next whole number; and**
- **Less than five-tenths, the number of licenses shall be rounded down to the next whole number.**



Quota Statute

17-3-16 (NMSA 1978)

If the number of applicants in a specific pool applying for licenses do not fill the pool, undersubscribed licenses may be given to another pool. The director shall offer first choice of undersubscribed hunts to residents, whenever practicable.

Rule 19.31.3 (O)

O. Director's authority to adjust licenses and permits: The director may adjust licenses or permit numbers for special drawings, by no more than one per hunt code, to comply with Chapter 17 NMSA 1978 and its corresponding rules.



2019 Draw

- **Total of 884 hunt codes in the draw**
- **566 had the potential to round**
- **272 hunts had one license added to account for rounding**



Recommendation

- **No longer add an additional licenses to account for rounding.**
- **Ensure residents receive minimum of 84% of licenses.**

License Setting

- **Collect population data.**
- **Determine projected success rates by weapon type and set license numbers.**
- **Allocate determined license numbers to manage hunter densities and population goals.**
- **Make recommendations to Commission for approval.**



Random Draw

- **All applications assigned a random number.**
- **Application are gone through in sequential order.**
- **Second pass if licenses are remaining.**
- **Quadrant draw for deer and elk.**
