Population Information

Habitat Model (Costello et al. 2001):

- Used GIS
- Primary habitat = 40,732 km² (13% of NM)
- Improved habitat classifications allow for improved model results
- Preliminary results suggest an increase in primary habitat


Population Information


Average Ages of Black Bear Mortalities from 1999-2014



Bears: Proposals for Consideration

- Harvest limit increase in specific Bear Management Zones (BMZs)
- Move Game Management Unit (GMU) 48 from BMZ 3 to BMZ 4
- Add GMUs 39 and 40 to BMZ 6
- Potential modifications to season structure
- Potential modifications pelt tag reporting

CURRENT

- The hunter or a designee may present the pelt
- Any NMDGF employee may tag the pelt

PROPOSED

 The hunter would be required to make contact (in person or via telephone call) with a game warden


Maximum Allowable versus Actual Cougar Harvest 2011-2015

Cougars: Proposals for Consideration

- Allow use of traps and snares to harvest cougars to reach harvest limits. CMZ L would be excluded
- Prohibit use of hounds during
 September deer and elk archery seasons
- Allow licensed deer and elk hunters on certain Wildlife Management Areas to hunt cougars during their hunt
- Move Game Management Unit (GMU) 18 from CMZ I to CMZ H
