

**NEW MEXICO DEPARTMENT OF GAME AND FISH
EPLUS SPECIAL MANAGEMENT ZONE LANDOWNER LIST
APRIL 1, 2024 - MARCH 31, 2025 HUNTING SEASON**

The following ranches have been issued private land elk authorizations for deeded acres enrolled in EPLUS within the Special Management Zone, which may be bartered, sold, or traded to hunters. The Special Zone includes all of GMUs 55A and GMU 54 west of State Road 199.

This list is provided as a courtesy of the Department of Game and Fish. Any arrangements for the authorizations are considered a private matter. The Department is not a party to these communications, will not act as a go-between, and is not responsible for resolving disputes. Please be sure the terms and conditions for all arrangements and contractual obligations are clear to all parties involved.

Private land elk licenses may be purchased in person at NMDGF offices and license vendors, online at <https://onlinesales.wildlife.state.nm.us>, or by calling 1-888-248-6866. Online and telephone purchases must be made at least 14 days prior to the hunt to allow time for mailing. For additional information about licensing options and requirements, please visit the licenses and permits section on our website at www.wildlife.state.nm.us or review the current New Mexico Rules and Info booklet.

All authorizations issued within the Special Management Zone are Ranch-Only. They are only valid on the private land of the issuing ranch; however, they may be used on other private land within the same GMU and management zone with written permission from the landowner.

The EPLUS landowner list may be updated periodically throughout the Summer and early Fall as landowners sign their agreements and are issued authorizations.

Key:

Ranch-Only (RO) - All authorization issued within the Special Management Zone are ranch-only. A RO authorization allows a hunter to purchase an elk license valid only on the deeded acres of the designated ranch, they are not valid on public land. In the Special Management Zone ranch-only licenses may also be valid on other private lands within the same GMU with written permission from the landowner.

ES -An Either Sex designation gives the hunter an option to choose from the rifle season (Oct 1-Dec 31) or the archery season (Sept 1-24).

A - An Antlerless designation can only be used during the rifle season (Oct 1-Dec 31).
