- Changes to regular waterfowl and webless game-bird-season dates, based on public comment and calendar dates.
- No changes to the number of sandhill crane draw permits. Changes to sandhill crane season dates, based on public comment and calendar dates.
- Bag limit for northern pintail to remain at one per USFWS regulatory framework.
- No changes for dove or band-tailed pigeon seasons.
