The Director of the Department of Game and Fish may grant a permit to any person to carry out acts which are prohibited by the Airborne Hunting Act [17-3-43 NMSA 1978]. Permits shall be granted only to protect or aid in the administration or protection of land, water, wildlife, livestock, domesticated animals, human life or crops. Each person operating under a permit shall report to the Director of the Department of Game and Fish each calendar quarter, the number of animals so injured, captured or killed [17-3-47 NMSA 1978].

Send reports, in writing, 2 weeks prior to the last day of each quarter (March, June, September, and December).

I understand that I cannot exceed the number of predator nuisance animals authorized to be taken as permitted and hereby state that I have read and shall comply with the New Mexico laws governing predator nuisance control from aircraft and subsequent amendments to the laws.
