Share with Wildlife 2018 Final Report

Wildlife Rehabilitation Hospital

In the period from January 1, 2018 to December 31, 2018, New Mexico Wildlife Center admitted 656 animals to our wildlife rehabilitation hospital. The attached document contains a complete list of species, date admitted, reason for admission, and disposition. There are seven animals that were held over from 2018 into 2019.

We have had some changes and made some significant improvements in our hospital this year. We added two new incubators for initial care of injured and young animals. We have started improvements and remodeling of many of our pre-release enclosures, making sure they meet Minimum Standards. A second full-time staff person joined the hospital staff in February. Haley Sharpe brings with her experience in the field from both WildCare Foundation in Oklahoma and Bay Beach Wildlife Sanctuary in Wisconsin. Both she and our other fulltime hospital staff person, Hilary DeVries, achieved their Wildlife Rehabilitator Certification during 2018, and Ms. DeVries also acquired her certification as a Euthanasia Technician.

Four veterinarians volunteered time to assist our rehabilitators in the hospital, and two of them make rounds regularly at NMWC. Dr. Sarah Sirica from Thaw Animal Hospital visits onsite one to two times each month, and Dr. Julie Breer of Smith Animal Hospital is onsite at least weekly. Both also perform examinations and treatments for our patients at their hospitals and are available for consultation nearly 24/7.

As of January 1, 2018, we also switched to an online record-keeping system called Wildlife Rehabilitation MD (WRMD). Although there has been a learning curve as we integrate this new system into our procedures, it has been a great benefit to us in being able to pull together data. We look forward to being able to provide even greater insight into wildlife health as we continue to use this database for many years to come. Another benefit of this system is that as many as five other rehabilitators in New Mexico (and many outside of the state) also use WRMD, facilitating the sharing of information and the transfer of animals since records can be shared electronically and in real time.

As members of the community bring injured wildlife to our facility for rehabilitation, we are in a unique position to provide education about wildlife in our state. Our staff spoke to each rescuer about the injuries suffered by the animal they found, including how to prevent such injuries in the future. We also fielded well over 600 phone calls from people in New Mexico who had questions about wildlife around their homes.

Wildlife & Science Education

In the period from January 1, 2018 to December 31, 2018, New Mexico Wildlife Center staff and volunteers presented 102 wildlife education programs (including meet & greet events) to approximately 4,176 children and adults in New Mexico. The vast majority of these were for school-aged children, but we presented a few programs for adult and college-level groups as well. Six programs were provided to at-risk youth in Santa Fe County through Santa Fe County Youth Development.

Wildlife education programs at NMWC vary based on age group, but each program allows the audience to see animals from New Mexico up close. Meeting our Ambassador Animals fosters a connection between the audience and wildlife that would be impossible otherwise.

All of our wildlife education programs raise awareness about the value and importance of wildlife and ways of conserving both wildlife and their habitats. Additionally, they foster a connection to wildlife and nature that empowers and encourages people to take action to help wildlife and to simply enjoy the outdoors.

The Animal Ambassadors participating in these programs are housed on-site at New Mexico Wildlife Center and provide an educational opportunity for visitors to the center. In 2018, approximately 1,950 people came through NMWC to complete the self-guided tour of our Ambassador Animal displays. We also hosted a few educational events for families during the year:

- Wildlife Hospital Open House (February) 99 people attended
- Migratory Bird Day Celebration (May) 110 people attended
- Annual Open House (October) 345 people attended
- Camera Day (November) 20 people attended

Total visitation at these onsite events was 574.

A new education opportunity at New Mexico Wildlife Center in 2018 was "Animal Encounters." Between Memorial Day and Labor Day, visitors to NMWC had the chance to meet one of our Animal Ambassadors up close and learn about its behavior, natural history, and how we care for it at the Center. These were held three times daily at 10:00, 1:00, and 3:00 and had a total attendance of approximately 373 people throughout the summer.

Three week-long summer camps also were led in 2018 by NMWC staff. Two took place offsite, at Abiquiu and Heron Lakes, while one "wildlife camp" also took place at NMWC. We had a total of 30

children attend these camps, learning not only about wildlife, but also outdoors skills like kayaking and birdwatching.

During 2018, NMWC acquired a few new Animal Ambassadors for use in wildlife education programs. These include a Peregrine Falcon, a young female Swainson's Hawk, and a Barred Tiger Salamander.

NMWC Education Animal Curator, Shawna Protze, is responsible for the daily husbandry of these animals. Shawna trains our Animal Ambassadors with the assistance of two other Education Staff members, Executive Director, Melissa Moore, and a number of volunteers.

River Classroom, our unique science education program, continued in 2018 as well. During the spring semester, River Classroom was led by Christy Wall. She met with approximately one hundred students from five schools in Rio Arriba County between two and four times each month during the school year. The program re-started a little later than usual in the fall, and at a reduced rate as we brought in a new teacher for the program, Alex Patia (see below). Between mid-October and December 31, Alex met with two classrooms (at McCurdy and Tierra Amarilla schools) beginning in November. This program will increase again in 2019.

Two new fulltime staff members joined our education team this past year. Alex Patia started in October and is our new Education & Outreach Manager (replacing Christy Wall); he holds a Master's degree in Environmental Education and has worked in the field since 2006. Jarrod Klopp started as our Education Coordinator (replacing Jenny Tato) in November 2018 and has degrees in both Biology and Psychology, as well as a Certificate in Environmental Education and Sustainability. He brings experience in environmental education and training ambassador animals from places like Gabbert Raptor Center and Wolf Ridge ELC in Minnesota.
