



DRAFT Citizen Advisory Committee 2021 Prioritized Project Tracking

Public Land User Stamp 19.34.6

In 2021, the Citizen Advisory Committee held two separate prioritization meetings. The first meeting took place in July of 2021, while the second meeting occurred in November of 2021. The second meeting was unique in that the projects that were prioritized were designed solely for the benefit of fish and aquatic habitat. In total, the budget available between the two prioritizations was \$3,250,000.

In the August meeting a total of 26 projects were prioritized, with one project being removed from consideration after a CAC vote (seven springs cut and pile). In total, 18 of those projects were implemented successfully, resulting in thousands of acres of forest restoration through thinning and prescribed burns, improved wildlife habitat connectivity through installation of wildlife friendly fencing across several miles of public lands, wildlife water installations, erosion control and off highway vehicle management.

In November, a second special prioritization meeting was held in order to prioritize large, landscape scale fish habitat projects. This fish project prioritization was implemented because of the new condition that a minimum of 50% of habitat stamp funds benefit fish habitat, as per the recently renewed public land user stamp rule. In total, eight projects were brought forward, with one removed from consideration following a CAC vote (Polvadera Creek). Implementation of these projects spanned three state fiscal years. In total, five of the prioritized projects were implemented. The Hondo Tribs Slip Liner project was canceled due to the inability of the NMDOT to execute their portion of the project. Chihuahuenos Creek was canceled by the USFS due to logistical problems. The five completed projects resulted in significantly improved fish habitat that will enhance angler opportunities.
