- Fisheries projects: Stocked Rio Grande cutthroat trout salvaged during Calf Canyon burn into Middle Ponil Creek in Canadian River drainage. Completed kokanee salmon surveys in Navajo lake. Restocked Rio Grande suckers and Rio Grande chub from the East Fork of the Jemez River into Rio Frijoles on the Bandelier National Monument. Tagged 14,000

- largemouth bass from the Rock Lake hatchery and released them into Bill Evans, Lake Roberts and Clayton Lake as part of a research study.
- Wildlife projects: Flew elk surveys from Sept 25-Oct 6 across the state. Department and New Mexico State University personnel cooperated on a ptarmigan banding project in the upper elevations of the Pecos Wilderness. Completed dove, quail and bighorn sheep surveys.
- Education Activities Education staff have presented at Women of the Outdoors, Eastern New Mexico State Fair, Chavez and DeBaca County Fairs, Southern New Mexico State Fair and Southeast New Mexico State Fair. Hired a temporary webmaster to finish website redesign. OHV program purchased helmets and goggles to give to youth class participants. Hunter education offered its first in-person class since the beginning of the pandemic and is working with several schools to offer hunter education in schools. The shooting sport's program Responsible Hunter initiative provided \$18,000 to 11 statewide shooting clubs to support youth shooting sports. Range cleanup days were conducted at Clayton and Tres Piedras shooting ranges. Staff attended the New Mexico Outdoor Economics Conference in Taos, which was supported in part by the department. The R3 program with assistance from Field Operations hosted a one-on-one squirrel hunting camp. The department is working to expand its 3-D archery program after a successful test.
- A new poach coach has made its apprearance at several events across the state.
