- The Middle Ponil Creek project (Valle Vidal) is continuing and Rio Grande cutthroat rescued from the recent wildfires will be restocked in mid-September.
- The Willow Creek project (Pecos Canyon) is continuing and Rio Grande cutthroat rescued from the

- recent wildfires will eventually be restocked.
- Capt. Mike Matthews of Las Cruces received the Shikar Officer of the Year award.
- This year's Govenor's Auction was hosted by Ducks Ynlimited and earned over \$171,000 for conservation across the state.
- Retirements in Sept.: Wildlife Disease Specialist Dr. Kerry Mower and Human Resources Chief Yvonne Torres.
- Monthly status reports to the commission were requested and discussed.
- A status update was provided on the redesign of the department's website.
- The finalization of the Glenwood Hatchery's improvements were discussed.
