I understand that making false statements or failure to disclose material facts will result in denial and voidance of registration. I am aware that failure to successfully complete this application may result in a processing delay and/or its rejection.

### NOTICE TO GUIDES AND APPLICANTS:

Applicants can apply any time of year, all registrations expire March 31<sup>st</sup> of each year in conjunction with over-the-counter licenses, unless otherwise revoked or suspended.

**DO NOT WAIT** until the last minute to renew or apply. Applications and renewals will be processed on a first come first serve basis; it may take 30-days or more to process, depending on the volume that is received at any given time.

New applicants must take the "NM Guide & Outfitter Examination" at their nearest New Mexico Department of Game and Fish office. Exams are given at every office Monday through Friday from 9am to 3pm; closed weekends and holidays.
