[Returned from Closed Executive Session]

CHAIRMAN KIENZLE: This Commission had adjourned into executive session, closed to the public. During the executive session, the Commission discussed only those matters specified in its Motion to Adjourn, and it took no action as to any matter. To put this in perspective, our special meeting today, the Director, Director Sandoval, has announced her retirement, effective December 31, 2018, could be earlier, it just depends on circumstances but that is the current date that we have. We are very sorry to see her retire. Alexa has done a wonderful job for both the Commission, the Department, the public and every other stakeholder and we wish she would stay

but understand that she has other things that she wants to do. So, her nominal date of retirement is December 31, 2018, but I do understand that that date may change, maybe sooner rather than later depending upon circumstances. So, that puts the Commission in the position of having to find a new Director. It is our hope to have a new Director in place probably by some time in November, to have, perhaps, some overlap and if there is no overlap, we'll take that as it comes as well but that's kind of our timeframe, we'll start a search process depending on action here from the Commission. We'll start a search process, we'll take in candidates like we did before, and basically move forward using the same model that we used with Director Sandoval. With that, I will entertain a motion with regard to a search for a new Director.

VICE CHAIRMAN MONTOYA: Mr. Chairman, I move to authorize the Chairman to announce a search for a new Director of the Department of Game and Fish, using his discretion to move the search process forward.

CHAIRMAN KIENZLE: Can I get a second?

COMMISSIONER SALOPEK: Second.

CHAIRMAN KIENZLE: Any discussion? All in favor?

CHAIRMAN KIENZLE: They ayes have it. So, using my discretion, we'll open the search on April 1. That search will close on June 1, at 5:00 pm mountain time. After that, we'll have one or more interviews of applicants, probably with a goal towards making a decision at a, probably another special meeting, in September, again with a start date somewhere around November 1, or sometime in November. That's kind of the timeline. The announcement will go out far-and-wide, you'll probably get a copy of it via email, but I would encourage members of the public, send this out to the organizations that you belong to. We want to get, cast as wide a net as possible to Final Copy

get as many qualified applicants as possible and get a great pool of people to take us, keep maintaining what we've got and hopefully take us to the next level. Any other comments or questions from Commissioners? Any comment from Mr. Dax?
