- The sudden and unexpected loss of Commissioner David Soules.
- Three significant retirements so far this year, including Russ Benjamin, Vince Olguin and James Comins.
 - During the first legislative session, there were several bills that could have affected the Department.
 - Budget and Capital will pass through as presented and additional funds were allotted through the SIKES Act.
 - The Governor signed SB32 on Monday.
- Record numbers of draw applicant and applications. We are ensuring PCI compliance and security. We are seeing an increase in outdoor activities as is noted with the increase in applicants.
- Ensuring compliance with federal grants and gearing up for the budget development cycle and instituting the

new fiscal year budget.

- Work with the New Mexico Department of Transportation to continue coordination of the Corridors Plan. Ground truthing is currently going on to ensure that what the computers are telling us is correct. Expect public meetings as the project moves forward.
- The Environmental and Ecological Planning Division is also leading our engagement as a cooperating agency in the Sun Zia Transmission Line.
- The Information Technology Division is ensuring system functions, ensuring code is up to date and secure. We are moving forward with the cloud-based Microsoft 365 platform.
- Law Enforcement is working on cases, working with state lands to open public access and installing a gate to open a space that has been closed, patrolling hunts and preparing to address depredation issues.
- FMD is nearing completion of the pond on River Ranch, which is a step toward recovery of the Chichihua Chub in the Mimbres Drainage.
- Glenwood hatchery renovations are moving forward with contracts getting put in place in the next few weeks, with work starting shortly after.
- The annual walleye spawn is underway.
- 173 animals captured and collard to evaluate migratory herds in the north-central region.
- 1,000s of native plants were planted along the Canadian River as part of a project with the State Lands Office and plantings at Bernardo and Huey Wildlife Management Area.
- The annual wolf count was completed, with a minimum of 186 wolves.
