- Bird Die-off Several staff are working on the die-off, but at this time, there is not a report from the lab. The Department will provide more information at the next commission meeting.
- Officers are on patrol as hunting seasons are well underway. There have been many poaching cases and officers are working on several large cases.
- The 2021 WAFWA winter meeting will be held virtually. The status of the summer meeting is still unclear.
- The hearing results from the Legislative Finance Committee meeting will be coming later in October.
- Online engagement continues with the launch of the Bass Challenge and the Ladies' Social

Hour.

Lance Cherry presented the Department's proposed changes to the Hunter Education Rule 19.36.3 NMAC to allow first-time youth hunters, eight years of age and older, the ability to hunt small game, turkey, javelina, deer and pronghorn antelope for two license years in the Department's Mentored-Youth Hunting (MY) Program. The proposed age rollback would more effectively align with the minimum age requirement of 10 for online hunter education certification and allow hunting opportunities for pronghorn antelope. It would also add a requirement for mentors to complete an abbreviated hunter training course comprised of written lessons and testing and current registration in the Department's mentored-youth program or proof of New Mexico hunter training course or a hunter training course of another state which is approved by the New Mexico Department of Game and Fish and change the rule from permanent to a four-year cycle, April 1, 2021 through March 31, 2025.

Stewart Liley Presented the Department's proposed changes to the Habitat Stamp Program rule (19.34.6 NMAC) based on public comment and coordination with the federal partners from the Bureau of Land Management (BLM) and the United States Forest Service (USFS). Proposed changes include a reauthorization of the Rule for an additional ten years, a reduction in the number of appointed Citizen Advisory Committees (CAC), and the removal of redundancies in the planning process.

Matt Wunder presented the Department's request that the Commission approve the 2020 Biennial Review of state-listed threatened or endangered species pursuant to the Wildlife Conservation Act (17-2-40 NMSA 1978). The sole change recommended in any species' status is an uplisting from threatened to endangered for narrow-headed gartersnake.
