PUBLIC RULE HEARING OPEN

<u>HEARING ITEM NO. 1a (Informational)</u>: Rule Making Hearing on the Final Hunting and Fishing License Application Rule – 19.31.3 NMAC.

Chad Nelson, Assistant Chief of Licensing, presented the final rule changes to the Hunting and Fishing License Application Rule 19.31.3 NMAC which will become effective January 1, 2020, and will add species (sandhill crane, Barbary sheep and pheasant) available in the public draw, require applicants for all military-only hunts and returning Iraq/Afghanistan veteran hunts to submit proof of service prior to applying for public draw hunts and add the general license, permit and stamp requirements.

AGENDA ITEM NO. 11: Subsequent Discussion on the Trapping and Furbearers Rule19.32.2 NMAC

Stewart Liley, Chief of Wildlife Management Division, presented on the proposed changes to the Trapping and Furbearer Rule 19.32.2 NMAC based on public comment, harvest and biological data collected and information from recent literature. Proposed changes include:

- Require every trapper to complete a Department approved trapper education course;
- Prohibit the use of land sets on the Sandia Ranger District, the eastern portion of the Organ Mountain-Desert Peaks National Monument, and on Forest Service lands within ½ mile of NM Hwy 475 on the Santa Fe National Forest and NM Hwy 150 on the Carson National Forest:
- Create a setback distance of ½ mile from a designated trailhead;
- Require snares on land to have a break-away device;
- Require traps to have at least two separate swivels points, one within six inches of the trap;
- Require stakes, chains, drags or other anchoring systems such that any furbearer or wolf will be prevented from escaping with a trap;
- Move manner and method from the Trapping and Furbearers Rule to 19.31.10 NMAC 1978 "Hunting and Fishing - Manner and Method of Take";
- Make the Trapping and Furbearers Rule a four-year rule.
