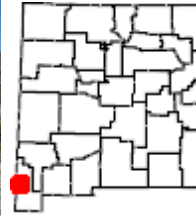




Weatherby Ranch, Cotton City, OG.155



Access Type: Hunting, Trapping.

Access hrs: 2 hrs before sunrise to 2 hrs after sunset.

GMU: 27





Information and habitat: Weatherby Ranch consists of 3,200 deeded acres located just west of Cotton City, NM. The lower elevations of Weatherby Ranch are dominated by desert grassland interspersed with honey mesquite and creosote bush. These habitats attract Javelina, dove, quail and act as travel corridors for mule deer. Approximately 118 acres in this lower elevation consists of an irrigated agricultural field planted in corn and winter wheat attracting Sandhill cranes, dove, quail, Javelina, and mule deer. Higher elevations support mule deer, quail, and dove.

Permitted Uses: Hunting and trapping is permitted on this property during the seasons and dates specified in the Open Gate lease agreement between the Department of Game and Fish and the landowner. Access to the property is subject to the terms and conditions in the Open Gate lease agreement and is restricted to the following permitted activities:

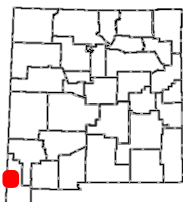

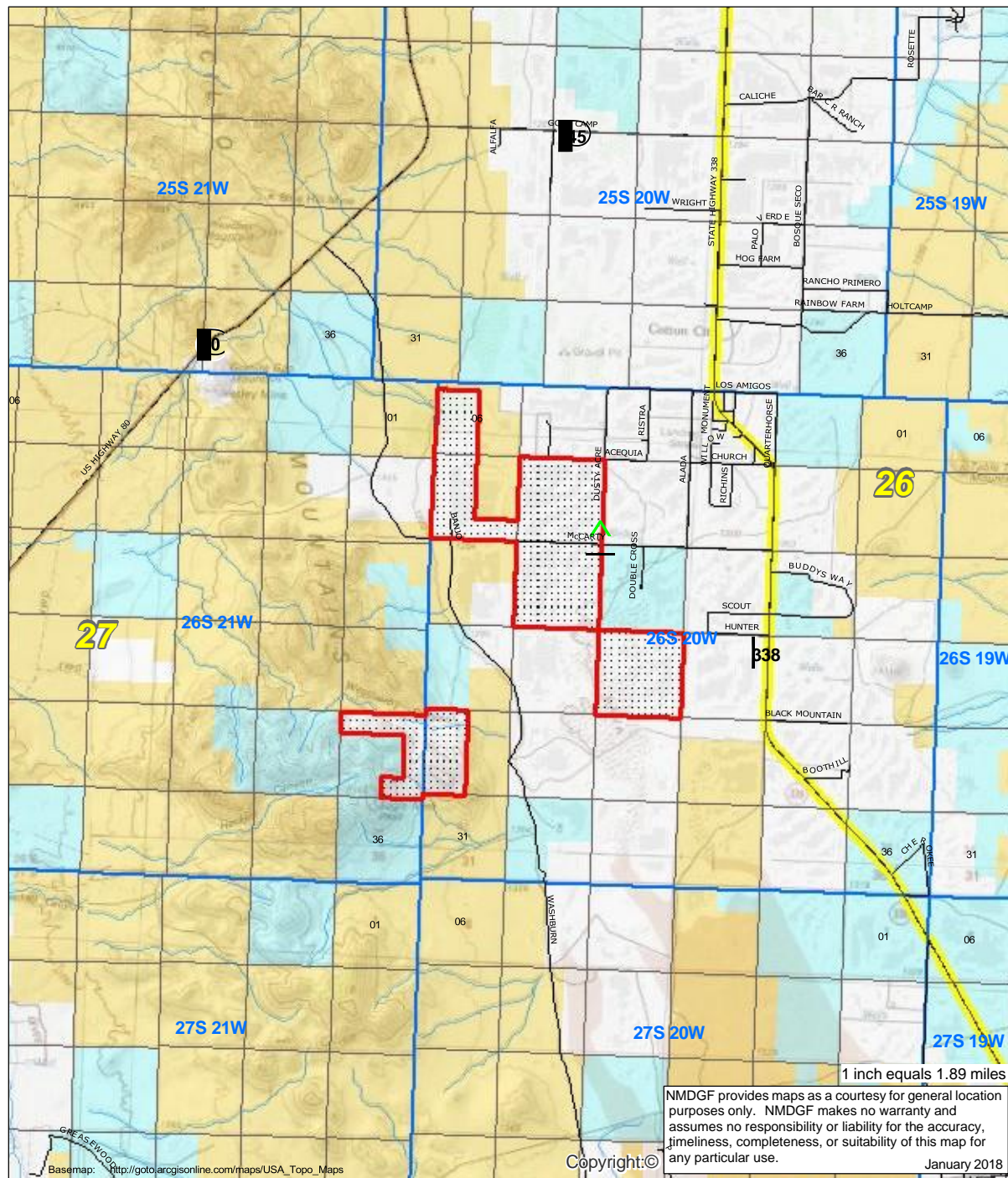
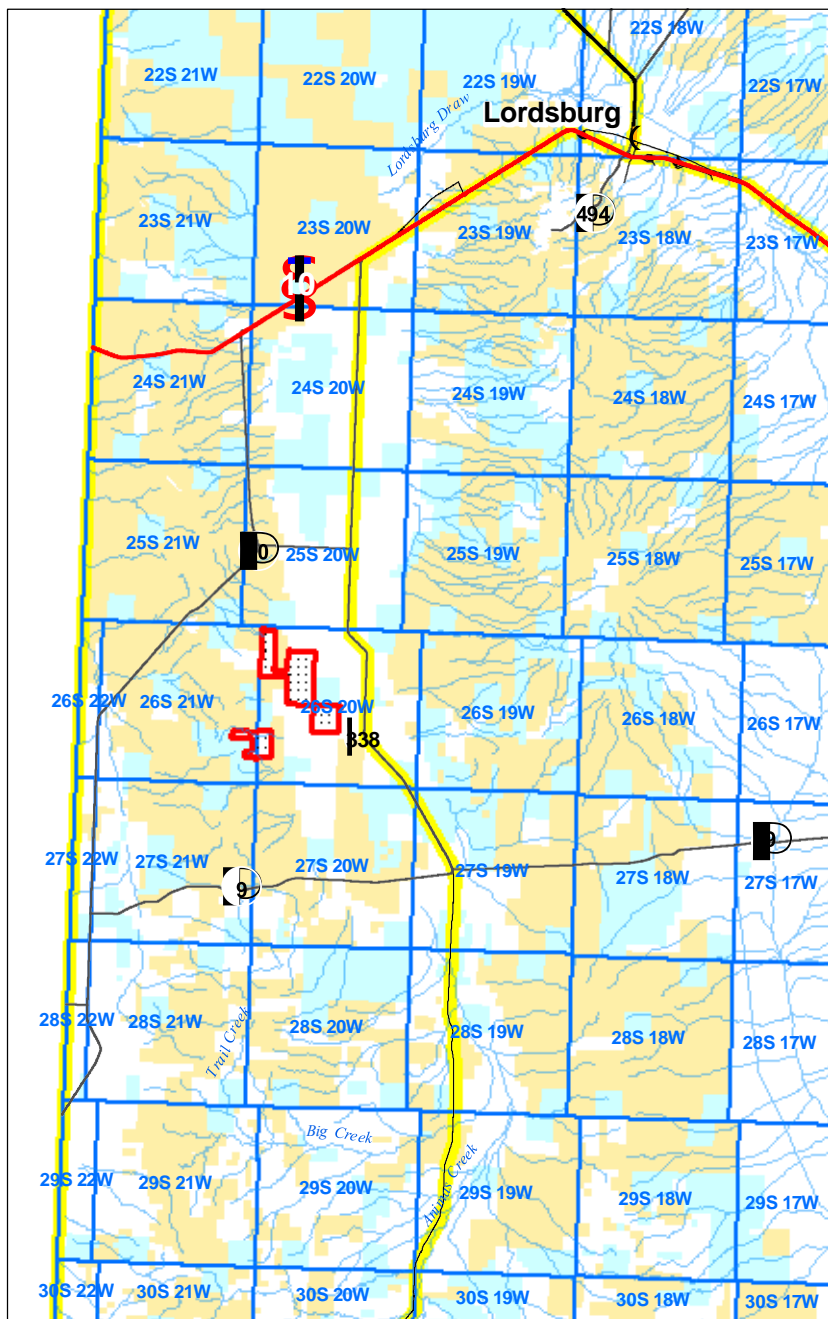
Property Rules: The following rules will be posted on this property and enforced at the discretion of the Department of Game and Fish.

- This Open Gate Property is restricted to properly licensed users for the following activities: **Dove Hunting, Quail Hunting, Sandhill Crane Hunting*, Bighorn Sheep Hunting*, Deer Hunting*, Javelina Hunting* (draw license hunters for Unit 27 only*), Cougar Hunting, and Furbearer Hunting and Trapping.**
- No access unless you are a properly licensed hunter or trapper.
- Each properly licensed hunter or trapper is allowed to be accompanied by no more than two guests.
- Scouting is only permitted during the two days immediately preceding the commencement of open season dates.
- No motor vehicle travel off designated roads or on closed roads.
- No destructive acts including: vandalism, graffiti, theft, removal or defacing natural features, resources or signs.
- No target practice.
- No consumption of alcoholic beverages.
- No camping.
- No fires.
- No littering.
- Access allowed from two hours before sunrise to two hours after sunset.
- **New Mexico Statute prohibits discharge of a firearm within 150 yards of a dwelling or building without permission of the structure's owner or lessee.**
