## **NEW BUSINESS:**

AGENDA ITEM NO. 5: OHV-related injuries in New Mexico -- Liana Lujan, RN, a Trauma Systems Manager from the State EMS Bureau, will present information on OHV-related injuries in New Mexico. Topics of discussion will include; severity, region of the body injured and demographic information. Part of her presentation is from a report that was presented to the Injury Prevention Bureau. The data is received from 17 hospitals in New Mexico. The act requires tracking of injury data and education for the public and the users relative to the safe use of off-highway vehicles.

**AGENDA NO. 6: Off-Highway Motor Vehicle Identification --** License display and vehicle registration are a crucial component of compliance. The Department needs to resolve the issues surrounding registration display options on Off-Highway Vehicles (OHV). The Department will consider input from the Board, law enforcement, OHV users, and other stakeholders who are impacted by the visibility and readability of OHV identification. The Department will give a presentation on OHV identification, registration and license display as it relates to other Western States.

State law includes the following language: – "shall, in cooperation with the Division, determine the size, composition, attachment mechanism, letter or number height and other properties of off-highway motor vehicle identification. This identification may be a traditional license plate, stick-on lettering as used for both identification or another form of identification that is visible and readable;" New Mexico Off-Highway Vehicle Act (66-3-1018, B.17)

**AGENDA ITEM NO. 7: General Public Comments --** (Comments Limited to 3 Minutes per speaker).

**AGENDA ITEM NO. 8: E-Course Update --** The Department will update the Board and the public on the progress toward development of OHV user safety training courses for New Mexico. Board members have requested information related to:

**AGENDA ITEM NO. 9: Changes to Off-Highway Vehicle Rule --** Prior to the last Advisory Board meeting, the Department provided an updated draft of changes to the Off-Highway Vehicle Standards rule (18.15.3 NMAC) to incorporate changes related to safety training and other modifications necessitated by changes in law.

**AGENDA ITEM NO. 10: OHV Program Budget --** The Department will provide information related to the process it will use to solicit and fund grant proposals during fiscal year 2011. The Department will request input from the board and other stakeholders to determine areas of emphasis for grants.

The Department and Board have previously discussed grants in the following areas:

- Funding seasonal outreach and enforcement officers in high-use areas
- Grooming snowmobile trails and other trail maintenance activities
- Educational Outreach Statewide campaign, educational materials (brochures, posters, fliers, etc.), opportunities to
- Work in conjunction with Hunter Education, County Extension, Public Schools
- Signage, gates, berms, habitat restoration on road closure areas

The Department will also review fiscal year 2010 budget expenditures, and will explain how the Trail Safety fund, and its status as a non-reverting fund, relates to the annual legislative appropriation process.
