## **Obtaining an OHV Permit**

Registration is required for OHVs prior to using them on any public lands in New Mexico. Vehicles that are considered OHVs include:

- All-Terrain Vehicles (ATV)
- Dirt Bikes
- Off-Road Vehicles (ORV, UTV, or mule-type Vehicles)
- Snowmobiles

New Mexico Residents are required to register their OHV at any Motor Vehicle Division Field Office.
