Open Gate
Hunting and Fishing Access Program Application

Landowner Benefits:

Landowners receive monetary compensation for allowing public access. This is accomplished through a flexible agreement negotiated between the landowner and the Department. The program also offers liability protection under the terms of 17-4-7 NMSA 1978. Signs will be installed to manage public access and inform users of property specific rules. The property will also be patrolled by NMDGF Game Wardens to help ensure compliance.

Participation Requirements:

Lands or waters eligible for enrollment in the Open Gate program must provide suitable fish or wildlife habitat or access to quality habitat to support the recreational uses designated through an Open Gate agreement, and meet, at minimum, one of the following conditions: (1) enrollment will result in increased hunting, fishing or trapping access on private land; (2) enrollment will provide a meaningful access corridor to significant, otherwise inaccessible blocks of state or federal lands for hunting, fishing or trapping; or (3) enrollment will improve regional wildlife or fisheries management goals of the Department.

Enrollment Process:

Persons interested in enrolling in the Open Gate Program must submit a completed application and provide proof of ownership, or if leasing the property, a copy of the lease with a notarized and signed statement from the landowner authorizing program participation. All applications are subject to a Department evaluation to determine if the lands or waters proposed for enrollment satisfy the requirements found in 19.34.7.11 NMAC. If the property meets requirements, the department and landowner may negotiate an Open Gate access agreement.

Properties Desired:

The Department is seeking high quality properties that will offer sustained public hunting and fishing opportunities or access to such opportunities on public land. For properties to be considered for the Open Gate program, they must offer hunting or fishing directly on the property or enhance public land access in an area of the state where access is limited. Additionally, if a property is located in a part of the state where other land is available for outdoor activities, it must allow for a significant increase in hunting or fishing opportunities.
