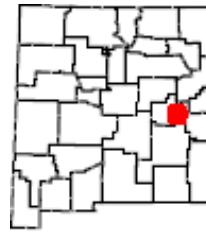
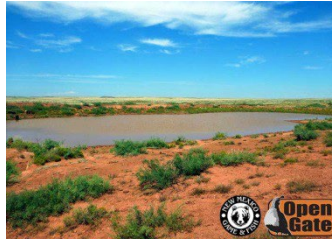




Lake Ranch, Fort Sumner, OG.109



Access Type: Hunting.

Access Hours: 2 hours before sunrise to 2 hours after sunset.

GMU: 32

Information: This property contains 4,121 acres located in GMU 32, approximately 20 miles southeast of Fort Sumner, NM off Urton Lake Rd. It also improves access to several thousand acres of neighboring State Trust Lands. This property is a working cattle ranch covered by a mixture of brush, mesquite, and native grasses, which provides good upland habitat. It has a few wells that supply water for the landowner's ranching operation. In wetter years, scattered dirt tanks will fill and hold water. Water sources provide good pass shooting opportunities for dove hunters. During better years, the area can provide some decent quail hunting.

Permitted Activities: Hunting is only permitted on this property during the seasons and dates specified in the Open Gate lease agreement between the Department of Wildlife and the landowner. Access to the property is subject to the terms and conditions in the Open Gate lease agreement and is restricted to the following permitted activities:

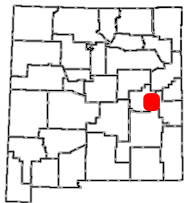

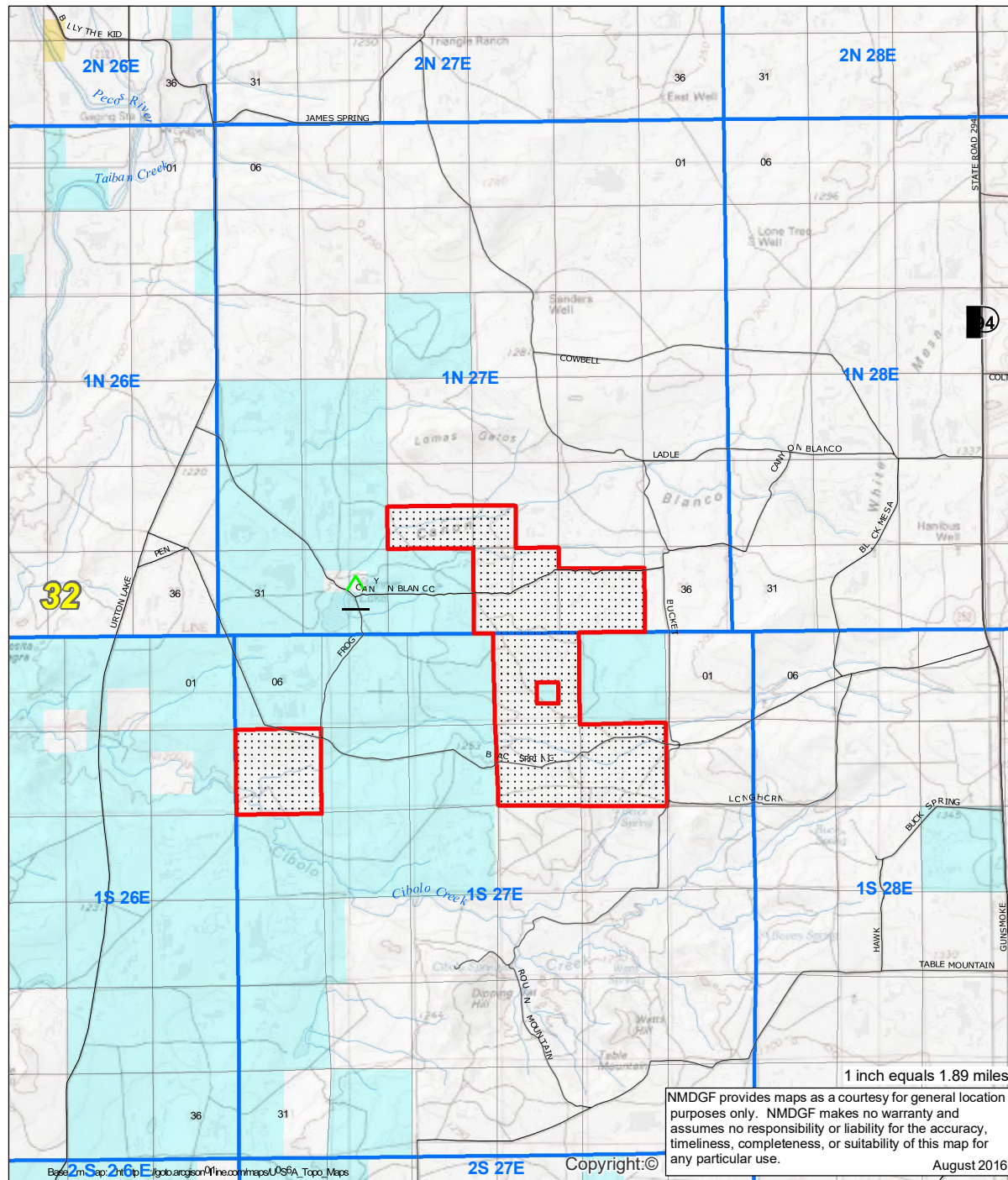
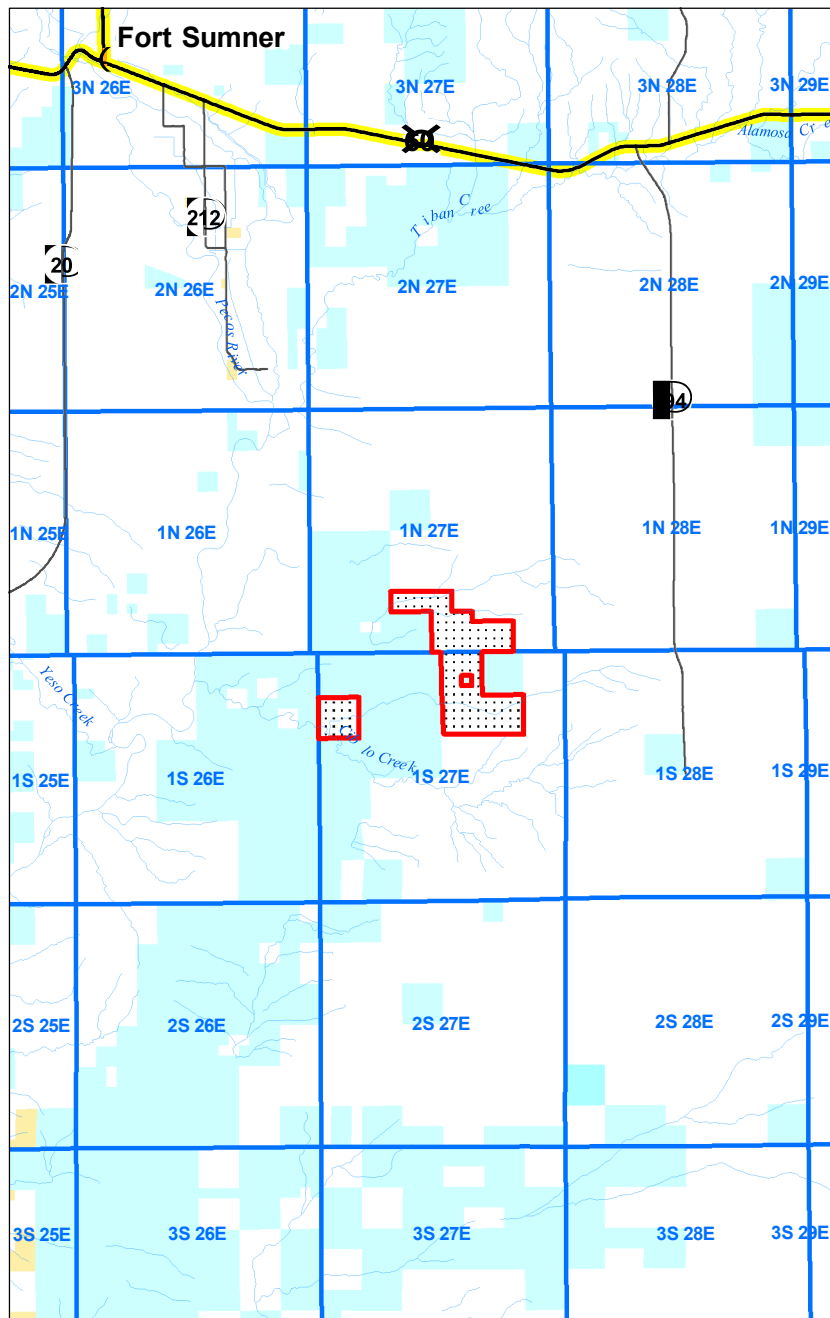
Property Rules: The following rules will be posted on this property and enforced at the discretion of the Department of Wildlife.

- Use of this Open Gate Property is restricted to properly licensed sportspersons for the following activities: **Dove hunting, Quail hunting and Pronghorn hunting (Draw hunters only).**
- No trespassing unless you are a properly licensed sportsperson, are accompanied by a properly licensed sportsperson or are license-exempt.
- Each properly licensed sportsperson or license-exempt person is allowed to be accompanied by no more than two guests.
- Scouting is only permitted during the two days immediately preceding the commencement of open season dates.
- No motor vehicle travel off designated roads or parking areas is permitted.
- No destructive acts, including: vandalism, graffiti, theft, removal or defacing natural features, resources or signs.
- No target practice.
- No consumption of alcoholic beverages or use of illegal drugs.
- No camping.
- No fires.
- No littering.
- Access allowed from two hours before sunrise to two hours after sunset.
- **New Mexico Statute prohibits discharge of a firearm within 150 yards of a dwelling or building without permission of the structure's owner or lessee.**
