



121 Access, Roswell, OG.121



Information: This Open Gate right-of-way lease across private property provides the only legal vehicular access into certain areas of public land. The property improves access to over 23,334 acres of State Trust and Federal lands that are difficult to access because there are limited public roads into the area. The property is located in GMU 33, approximately 50 miles southeast of Roswell, NM off Highway 172. This lease agreement gives hunters access to public lands, which hold dove, quail, deer, javelina, furbearers, and nongame species.

Permitted Activities: Properly-licensed sportspersons may travel across the landowner's property on designated roads for entering and exiting legally-accessible State and/or Federal lands during the dates specified in the lease agreement between the Department of Game and Fish and the landowner. Access to the property is subject to the terms and conditions in the Open Gate lease agreement and is restricted to the following permitted activities:

Properly licensed sportspersons may travel <u>across</u> the property on designated roadways connecting to legally-accessible State and/or Federal lands.	Aug. 1, 2024 – Mar. 31, 2025 (Closed April 1- July 31)	Game in the area may include dove, deer, quail, javelina, pronghorn antelope, and furbearers. Rabbits and coyotes may also be present.


Open Gate is a program that leases private lands to improve public access for hunting, fishing, and trapping. Open Gate leases are funded exclusively by hunters, anglers, and trappers through the purchase of the Habitat Management and Access Validation (HMAV).



Property Rules: The following rules will be posted on this property and enforced at the discretion of the Department of Game and Fish.

- Use of the Open Gate Property is restricted to public travel on the roads and trails designated for entering and exiting legally-accessible State Trust, Federal, and/or State Game Commission-owned lands for recreational purposes.
- No trespassing unless you are a properly licensed sportsperson, are accompanied by a properly licensed sportsperson or are license-exempt.
- Hunting, fishing, trapping, camping, and trespassing for any other purpose is prohibited on private lands without permission or consent from the landowner.
- No destructive acts, including: vandalism, graffiti, theft, removal or defacing of natural features, resources or signs.
- No motor vehicle travel is allowed off designated roads or on closed roads.
- No littering.
- No target practice.
- No fires.
- New Mexico Statute prohibits discharge of a firearm within 150 yards of a dwelling or building without permission of the structure's owner or lessee.
- Access allowed from August 1 to March 31.
