

STATE GAME COMMISSION MEETING AND RULE MAKING NOTICE

The New Mexico State Game Commission (“Commission”) will be hosting a meeting and rule hearing on Friday May 28, 2026 beginning at 9:00 a.m. at the NM Institute of Mining and Technology, Fidel Student Union Building, 801 Leroy Pl., Socorro, NM 87801. The purpose of this meeting is to hear and consider action as appropriate on the proposed changes to the Turkey Rule and the Javelina Rule.

Synopsis:

Turkey Rule

The proposal is to amend the Turkey Rule 19.31.16 NMAC which will become effective April 1, 2027. The most recent version of the rule will expire on March 31, 2027. The proposed changes are as follows:

1. Adjust hunt dates based on calendar dates
2. Increase up-to permit number for Gould’s once-in-a-lifetime hunt in GMU 26 and 27 to 15
3. In unit 8, increase permits from 15 to 20
4. Require the purchase of a license at least one day prior to hunting.

Javelina Rule

The proposal is to amend the Javelina Rule 19.31.21 NMAC which will become effective April 1, 2027. The most recent version of the rule will expire on March 31, 2027. The proposed changes are as follows:

1. Increase licenses in OTC areas - Any-legal weapon: 1,200 increase to 1,300 (8%)
2. Expand the validity of the GMUs 19, 23, 24, 25, 26, 27 (bootheel) javelina licenses to include OTC areas (excluding GMU 28), effectively making these “statewide” licenses. This approach is consistent with an existing youth hunt, which already allows this.
3. Eliminate GMU 28 hunt of 10 licenses (only 30% of hunters show up for hunt and its logistically challenging for the military to implement).
4. Require the purchase of a license at least one day prior to hunting.

19.31.16.1 ISSUING AGENCY: New Mexico department of ~~game and fish~~ wildlife.

19.31.16.3 STATUTORY AUTHORITY: Sections 17-1-14, 17-1-26, 17-3-16.4 and 17-3-16.5 NMSA 1978 provide that the New Mexico state ~~game~~ wildlife commission has the authority to establish rules and regulations that it may deem necessary to carry out the purpose of Chapter 17 NMSA 1978 and all other acts pertaining to protected mammals, birds and fish.

19.31.16.6 OBJECTIVE: Establishing open hunting seasons, rules and procedures governing the distribution and issuance of turkey permits and licenses by the department.

19.31.16.7 DEFINITIONS:

- A. **“Bearded turkey” or “BT”** shall mean a turkey with a visible beard.
 - B. **“Department”** shall mean the New Mexico department of ~~game and fish~~ wildlife.
 - C. **“Director”** shall mean the director of the New Mexico department of ~~game and fish~~ wildlife.
 - D. **“Entry permit”** shall entitle the holder of a valid turkey license to hunt areas otherwise closed to turkey hunting.
 - E. **“Game management unit” or “GMU”** shall mean those areas described ~~in~~ 19.30.4 NMAC Boundary Descriptions for Game Management Units.
 - F. **“Wildlife management areas” or “WMAs”** shall mean those areas described in 19.34.5 NMAC Wildlife Management Areas.

19.31.16.8 ADJUSTMENT OF LICENSES, PERMITS AND AUTHORIZATIONS: The director, with the verbal concurrence of the chairperson or their designee, may adjust the number of licenses, permits or authorizations for turkey up or down by no more than twenty percent to address significant changes in population levels or habitat availability. This adjustment may be applied to any or all entry hunt codes for turkey.

19.31.16.9 TURKEY ONCE-IN-A-LIFETIME-HUNTS: It shall be unlawful for anyone to apply for or hold a once-in-a-lifetime turkey entry permit if he or she has held a once-in-a-lifetime entry permit to hunt turkey.

19.31.16.10 TURKEY HUNTING SEASONS: The ~~2023-24~~2027-28 through ~~2026-27~~2030-31 hunting seasons shall be as indicated below, listing the GMUs or areas open, eligibility requirements or restrictions, hunt dates, hunt codes, legal sporting arms, number of permits and bag limits. All WMAs, except as listed in Subsection A of 19.31.16.10 NMAC, are open to over-the-counter turkey hunting if the GMU where they are located is open to turkey hunting or are restricted to entry permit holders as listed in Subsection B of 19.31.16.10 NMAC.

A. Over-the-counter hunts: All over-the-counter turkey licenses shall be valid for any legal sporting arms, except turkey hunting in the Sandia ranger district portion of GMU 14 and Sugarite canyon state park in GMU 57 ~~are~~ restricted to bow and crossbow only. The number of licenses for these hunts shall be unlimited.

B. Entry permit hunts: All entry permits shall be valid for any legal sporting arms except turkey hunting in the Sandia ranger district portion of GMU 8. An entry permit authorizes the holder to hunt in the area, for the bag limit, and for the season dates listed on the permit. In addition, holders of a turkey entry permit may hunt in any open over-the-counter area during the spring season for a second turkey (if applicable) or if unsuccessful in their entry hunt area. In no circumstance may any turkey hunter take or attempt to take more than two bearded turkeys during the spring season. Holders of an entry hunt permit must also purchase a turkey hunting license prior to hunting.

19.31.16.11 TURKEY POPULATION MANAGEMENT HUNTS:

A. The director or their designee may authorize population management hunts for turkey when justified in writing by department personnel.

B. The director or their designee shall designate the sporting arms, season dates, season lengths, bag limits, hunt boundaries, specific requirements or restrictions and number of licenses to be issued.

C. In the event that an applicant is not able to hunt on the dates specified, the applicant's name shall be moved to the bottom of the list and another applicant may be contacted for the hunt.

D. In those instances where a population management hunt is warranted on deeded private lands, the landowner may suggest eligible hunters of their choice by submitting a list of prospective hunters' names to the department for licensing consideration. No more than one-half of the total number of licenses authorized shall be available to landowner-identified hunters. The balance of prospective hunters shall be identified by the department.

19.31.16.12 GOULD'S TURKEY ENHANCEMENT PROGRAM:

A. The director shall collect all proceeds generated through the auction or lottery or both, of not more than two special Gould's turkey enhancement entry permits annually, and such monies shall be deposited into the game protection fund. These monies shall be available for expenditure by the department to be used exclusively for activities, projects and programs aimed at benefitting Gould's turkeys and Gould's turkey habitat, and for costs incurred in carrying out these programs.

- B.** Requirements for issuance, sale and use of Gould's turkey enhancement permits:
- (1) **Issuance:** The director may issue up to two Gould's turkey enhancement entry permits annually.
- (2) **Sale:** The auction or lottery or both shall be conducted by an incorporated non-profit organization dedicated to the conservation of wildlife, in cooperation with and overseen by the department.
- (3) **Use:**
- (a) The successful recipient(s) shall be allotted an authorization for a Gould's turkey enhancement entry permit, which may be transferred through sale, barter, donation or gift to other individuals qualified to obtain a license and hunt. Once an authorization is converted to a permit, the permit will be non-transferable.
- (b) Individuals hunting pursuant to a Gould's turkey enhancement entry permit must obtain and have in their possession a valid turkey hunting license and any other stamps, tags or permits required by rule.
- (c) Unless their hunting privileges have been revoked pursuant to law, any person is eligible to bid on and purchase a Gould's turkey enhancement entry permit.
- (d) Individuals holding a Gould's turkey enhancement entry permit shall not be prohibited from hunting other subspecies of turkeys in New Mexico as allowed in 19.31.16 NMAC.
- (e) The entry permit shall be valid for any legal sporting arms, and the bag limit shall be one bearded Gould's turkey.
- (f) The season dates for each entry permit shall be no more than 30 consecutive days between April 1 and May 31 as specified by the entry permit each license year.
- (g) The harvest of one bearded Gould's turkey shall count against the license holder's spring turkey bag limit.
- (h) The hunt area for each entry permit shall be any legally accessible public lands in GMUs 26 and 27 where hunting is allowed, and private land with written permission.
- (i) Gould's turkey enhancement entry permits granted through auction or lottery, as described above, shall not be considered 'once-in-a-lifetime' permits.

The rulemaking was undertaken to adopt a new Turkey Rule 19.31.16 NMAC which will become effective April 1, 2027. The most recent version of the rule will expire on March 31, 2027.

The new rule will include:

- Adjust hunt dates based on calendar dates
- Increase up-to permit number for Gould's once-in-a-lifetime hunt in GMU 26 and 27 to 15
- Conducted analysis of fall hen harvest, and this indicated that there are no units for which low-level harvest will negatively impact the population
- In unit 8, increase permits from 15 to 20
- Require the purchase of a license at least one day prior to hunting

B. Entry permit hunts: All entry permits shall be valid for any legal sporting arms except turkey hunting in the Sandia ranger district portion of GMU 8. (a) The successful recipient(s) shall be allotted an authorization for a Gould's turkey enhancement entry permit, which may be transferred through sale, barter, donation or gift to other individuals qualified to obtain a license and hunt. Once an authorization is converted to a permit, the permit will be non-transferable.

(b) Individuals hunting pursuant to a Gould's turkey enhancement entry permit must obtain and have in their possession a valid turkey hunting license and any other stamps, tags or permits required by rule.

(c) Unless their hunting privileges have been revoked pursuant to law, any person is eligible to bid on and purchase a Gould's turkey enhancement entry permit.

(d) Individuals holding a Gould's turkey enhancement entry permit shall not be prohibited from hunting other subspecies of turkeys in New Mexico as allowed in 19.31.16 NMAC.

(e) The entry permit shall be valid for any legal sporting arms, and the bag limit shall be one bearded Gould's turkey.

(f) The season dates for each entry permit shall be no more than 30 consecutive days between April 1 and May 31 as specified by the entry permit each license year.

(g) The harvest of one bearded Gould's turkey shall count against the license holder's spring turkey bag limit.

(h) The hunt area for each entry permit shall be any legally accessible public lands in GMUs 26 and 27 where hunting is allowed, and private land with written permission.

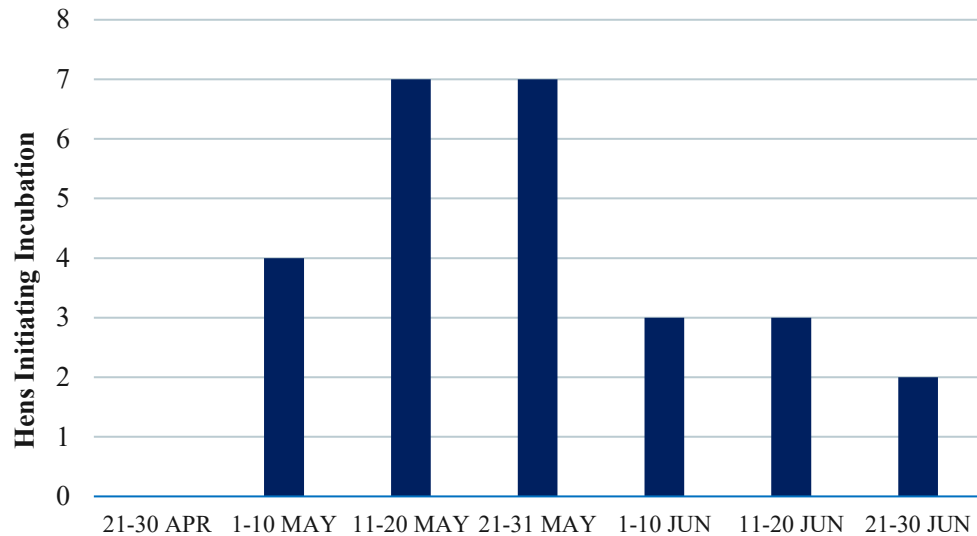

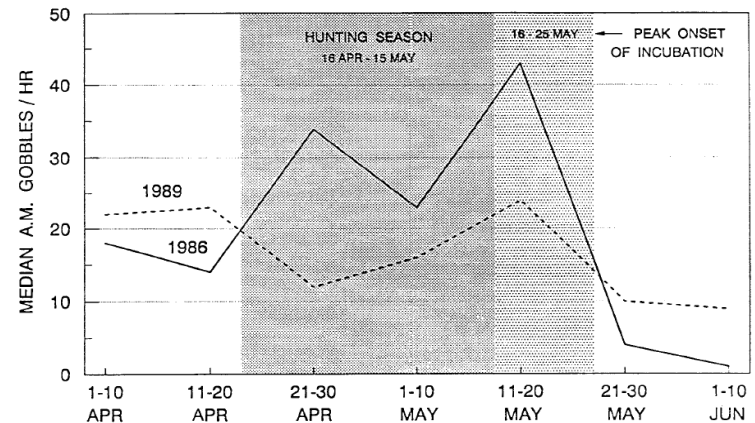


Fig. 1. Chronologic distribution of gobbling activity of adult male Merriam's wild turkeys in Colorado and New Mexico.

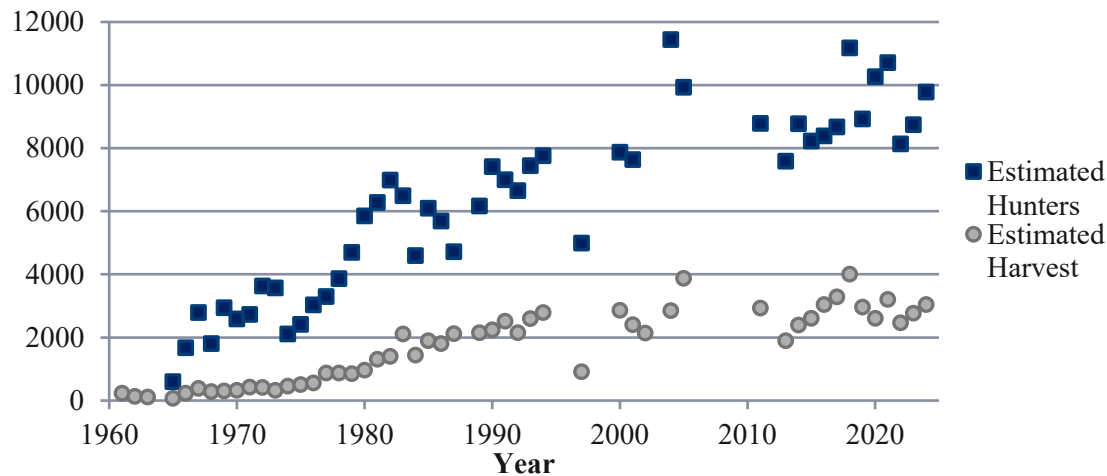

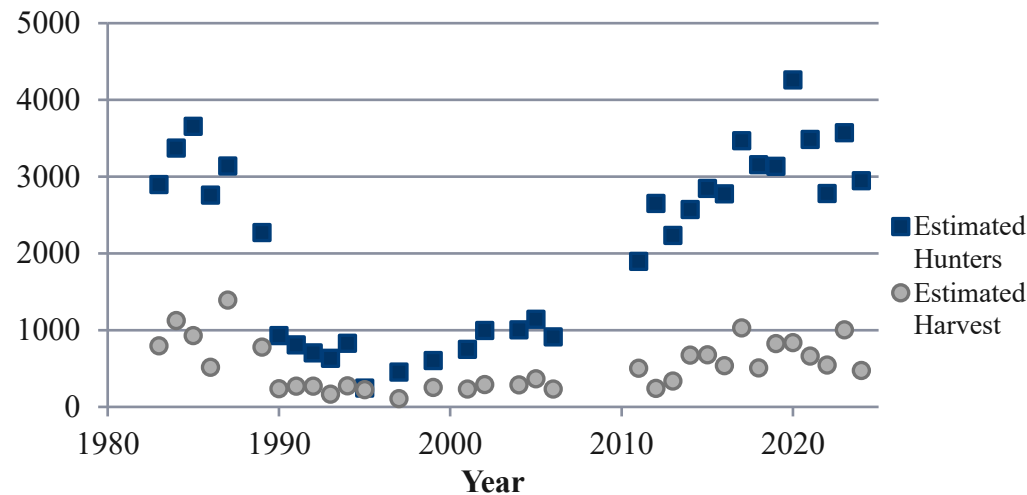

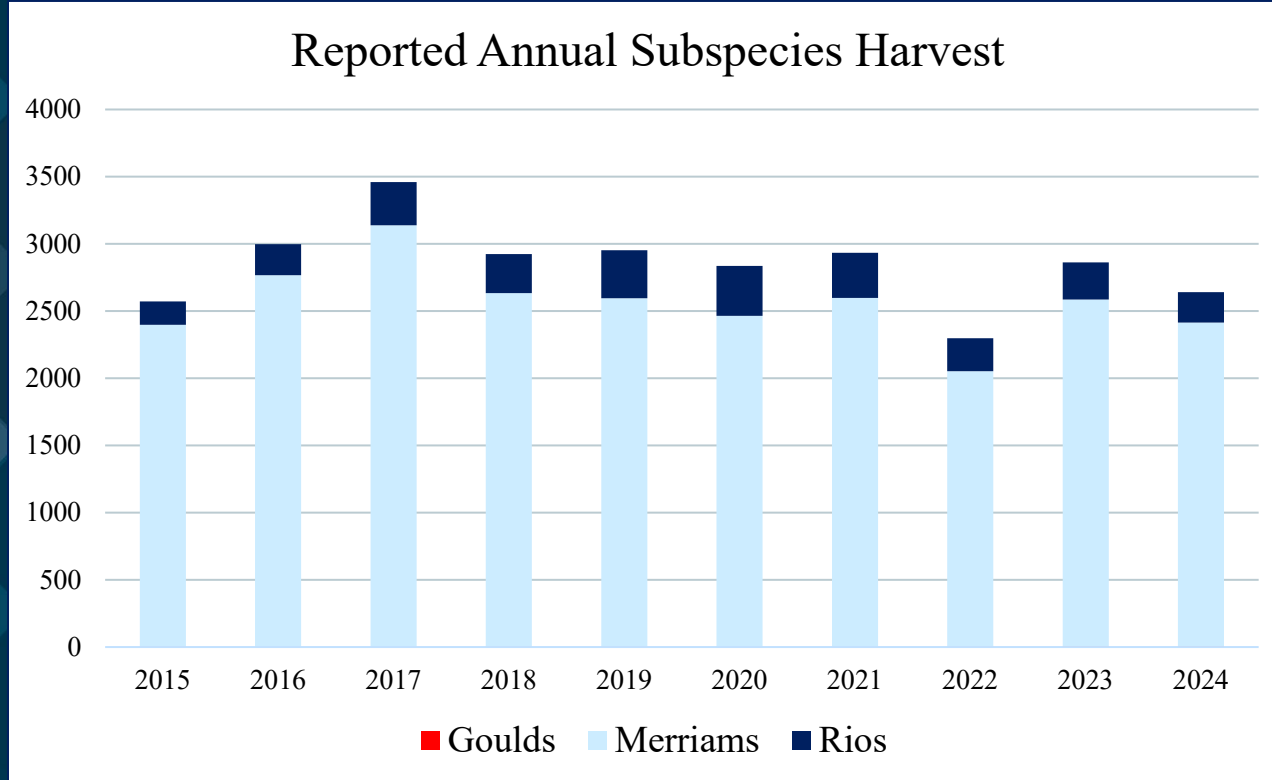

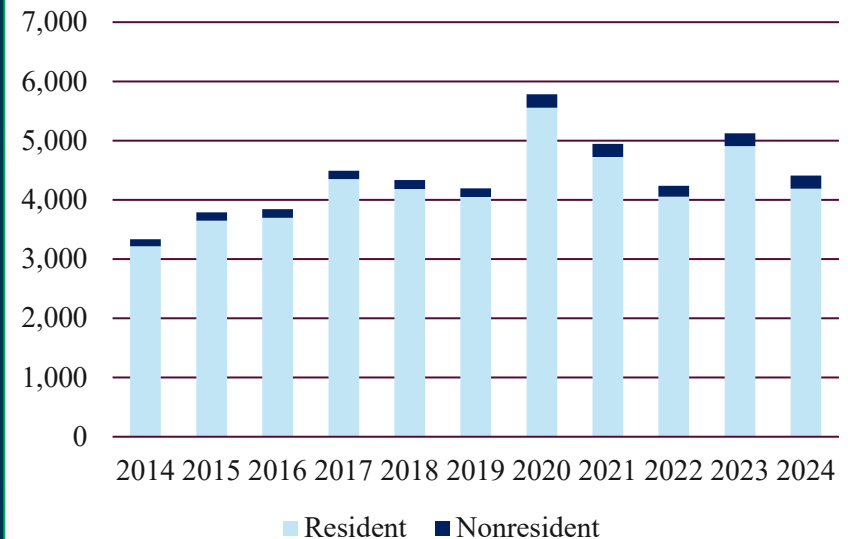

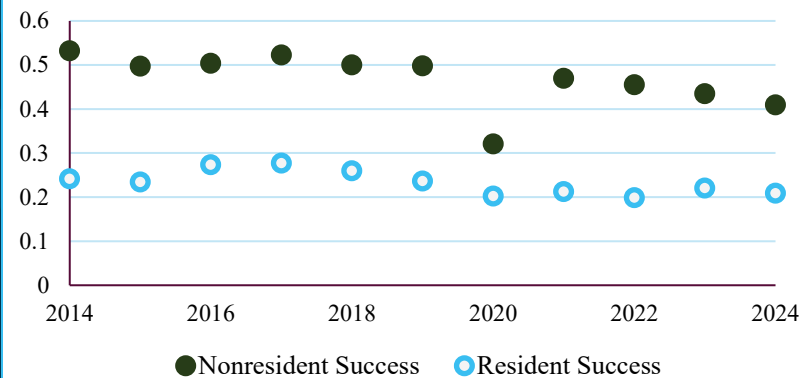

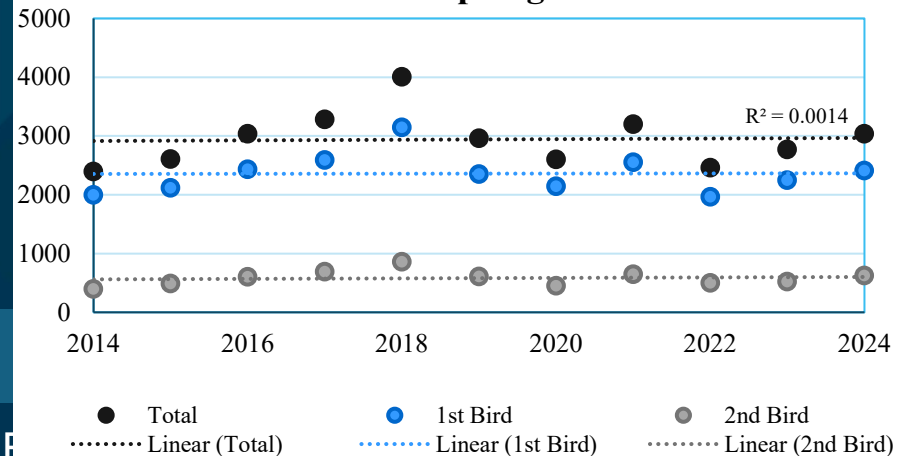

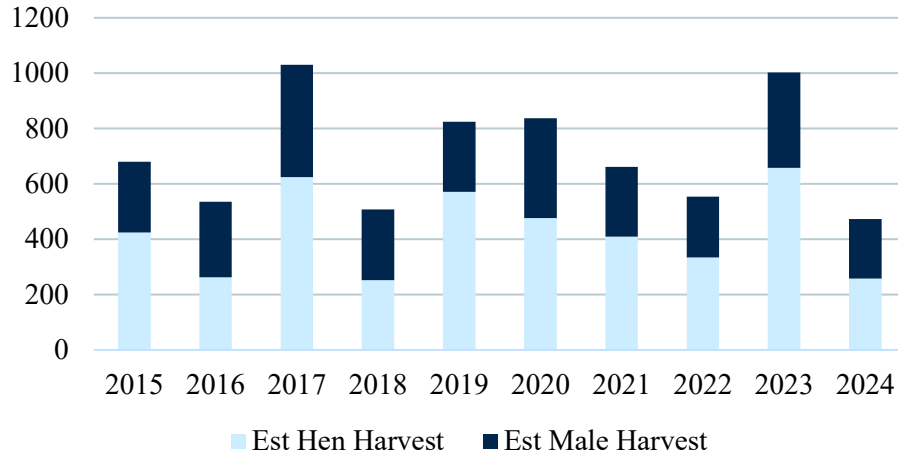

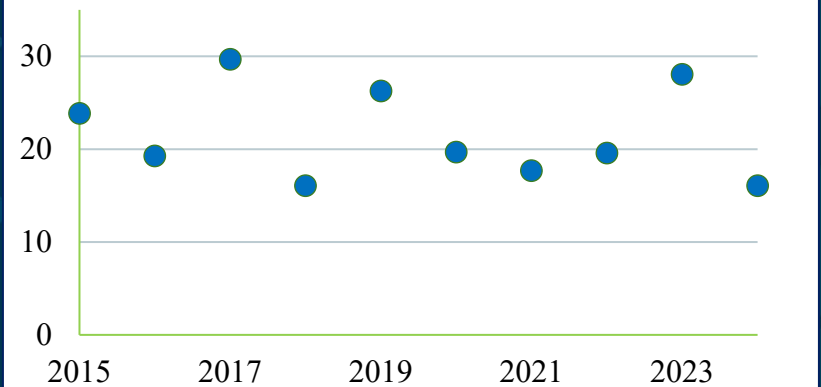

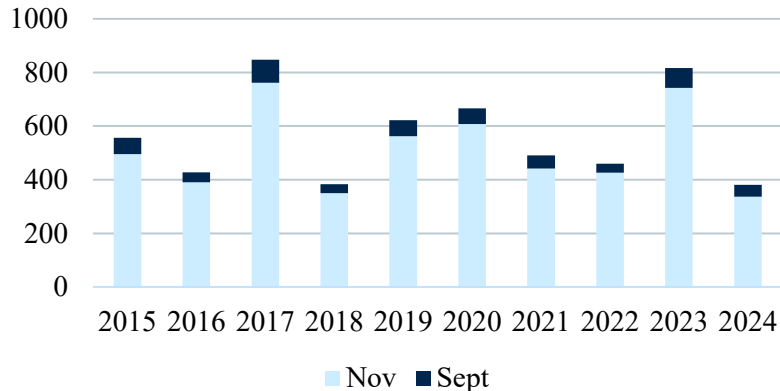
Fall Harvest Breakdown- Sex



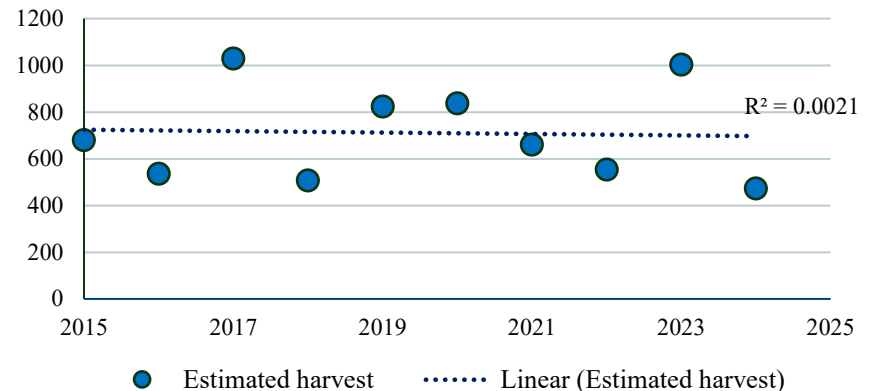
Fall Harvest Success Rates

PROPOSED TURKEY RULE SUMMARY, 2027-2031

Date of update: 4/10/2026

The turkey rule is amended every four years as part of the turkey rule development cycle. The current 4-year rule expires April 1, 2027. Proposed changes to the rule are made based on findings in scientific literature, data collected by Department staff, and public observations and recommendations.

Proposed amendments include:

- Adjust hunt dates based on calendar dates
- Increase up-to permit number for Gould's once-in-a-lifetime hunt in GMU 26 and 27 to 15
- Conducted analysis of fall hen harvest, and this indicated that there are no units for which low-level harvest will negatively impact the population
- In unit 8, increase permits from 15 to 20
- Require the purchase of a license at least one day prior to hunting

TECHNICAL INFORMATION FOR TURKEY RULE DEVELOPMENT

PURPOSE

Maintain current turkey populations and offer hunting opportunity that does not significantly impact turkey across the state.

TURKEY BIOLOGY AND HARVEST BACKGROUND

New Mexico is home to three subspecies of wild turkey (*Meleagris gallopavo*): Merriam's (*M. g. merriami*), Rio Grande (*M. g. intermedia*), and Gould's (*M. g. mexicana*).

Wild turkey populations are characterized by annual fluctuations, largely dependent on environmental conditions. Annual mortality rates can range from 30% to 55%, with most mortality occurring the first year of life. Rates decline after this time and remain somewhat stable for older birds. Most juvenile or yearling mortality occurs during winter. Hen mortality is highest between March and June. This coincides with the peak of incubation when hens are most vulnerable.

Wild turkeys exhibit a moderate potential for population growth. Reproduction is seasonal and the mating system is polygamous; males play no role in rearing young. All males ≥ 2 years old can breed. Females are capable of reproducing at 1 year of age, but adult hens are usually more successful at hatching nests than are yearlings.

Spring gobbler hunting is biologically the most conservative hunting approach and is unlikely to result in overharvest. Studies have shown that harvest of up to 30% of adult gobblers leaves enough for effective breeding and quality hunting the following season (Healy and Powell 1999). A spring seasons opener that is approximately 2 weeks before the peak onset of incubation will ensure that the majority of hens are bred prior to the removal of males from the year's breed stock. Fall harvest has the potential to depress population growth by the removal of hens and therefore hunting should be lighter during this time.

Turkey hunters will regulate themselves to a degree. Fewer hunters will go afield when population numbers are low, though hunters that do go at this time are more efficient. Turkey hunting in New Mexico is structured so that it does not negatively impact the turkey population.

Population Monitoring

The current statewide wild turkey population is unknown but based on calculations from Eriksen et al. (2015), the population could be estimated to be about 18,500 birds. The Breeding Bird Survey (BBS) can be used to understand broadscale changes in bird populations and distribution. BBS data can be used to summarize population change and relative species abundance (Sauer et al. 2013). Wild turkey population trends often follow weather patterns, with populations increasing in years with good environmental conditions, and declining during bad years. The Department has initiated a research project to evaluate Merriam turkey reproductive rates, onset of incubation, fall hen harvest rates, and habitat use. This project is in the early stages and will provide more population information in the upcoming years. New Mexico is participating in a nationwide brood survey, where individuals submit turkey sightings in July and August. Poult per hen ratios of 2:1 indicate stable population reproductive output. The statewide average from 2022-2025 is 2.21.

Since 2006, the Department has conducted spring Gould's turkey walking survey routes within the Coronado National Forest, where surveyors record all birds seen and categorize birds by age and sex. Initial survey focused on surveying roost locations identified in the 1980s and 1990s. A new survey protocol was established in 2019 which involves surveying locations received from deployed GPS transmitters.

Figure: BBS trend data for wild turkey in New Mexico.

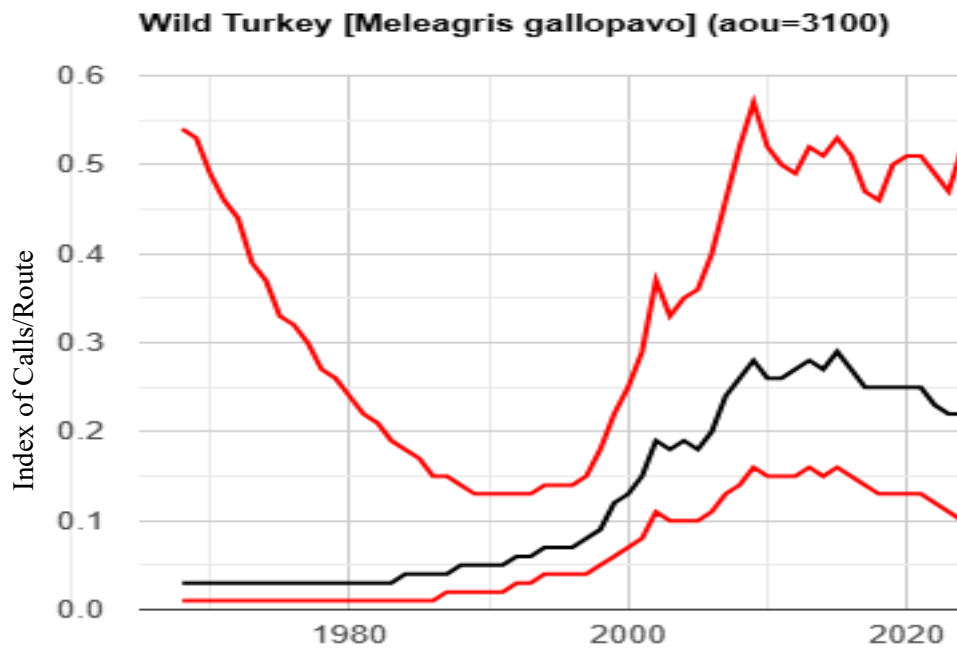

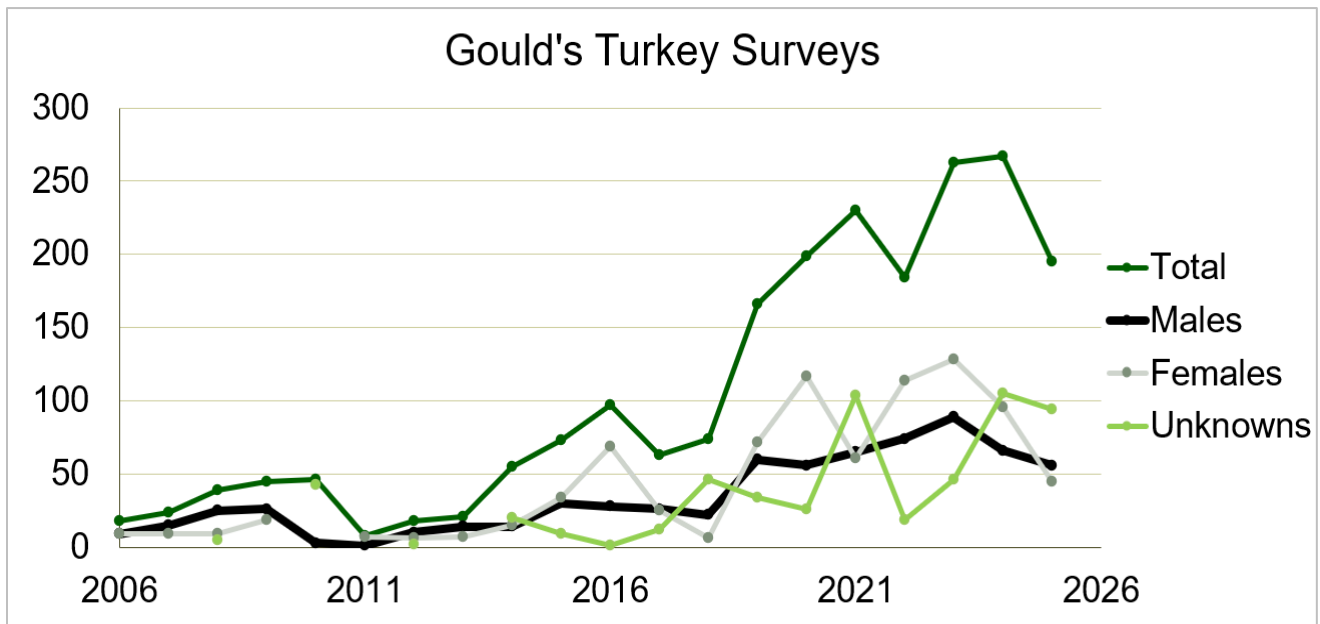


Figure: New Mexico Merriam turkey hen nest incubation onset from turkeys with GPS transmitters in 2025

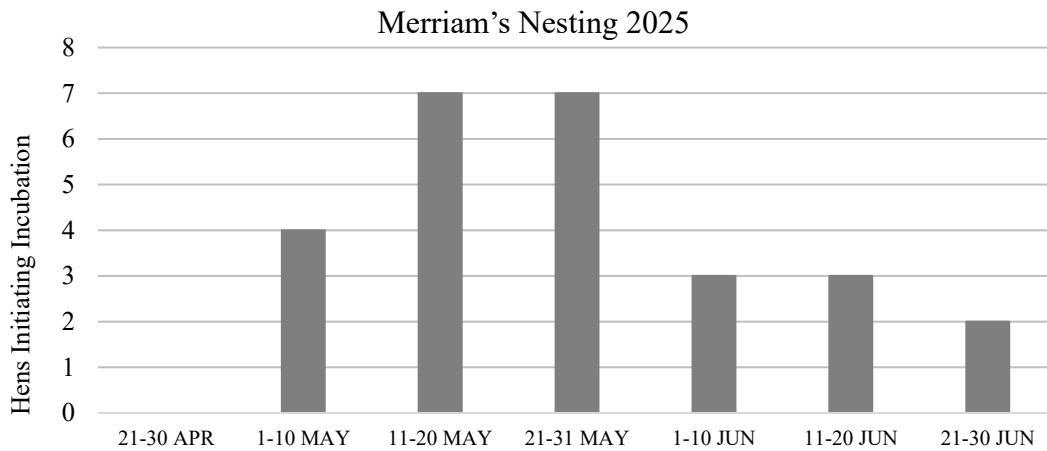


Figure: New Mexico Merriam turkey hen nest estimated onset of incubation of radiomarked turkeys in 1986 and 1989

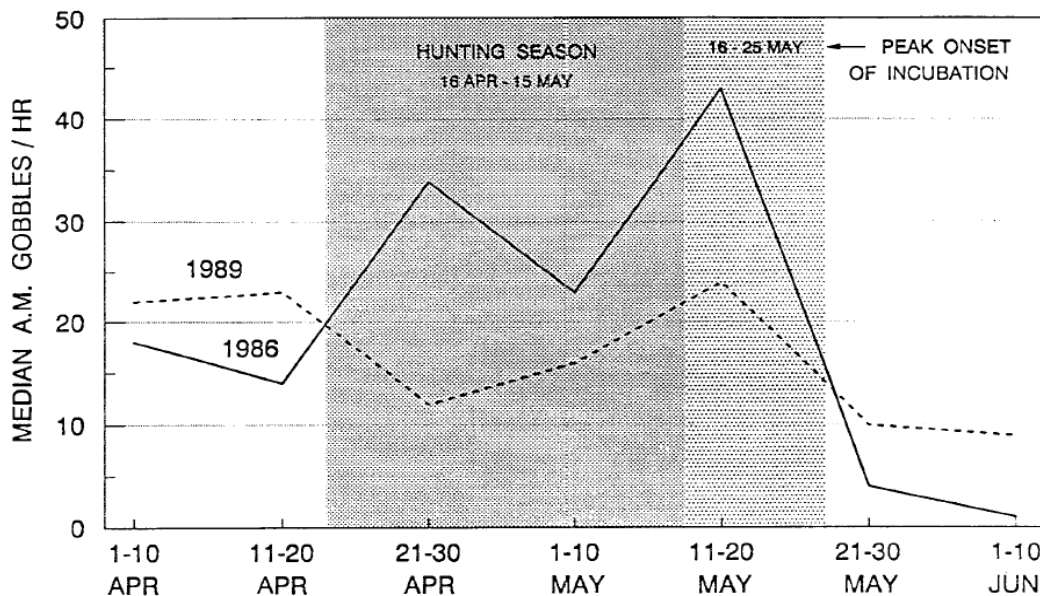


Fig. 1. Chronologic distribution of gobbling activity of adult male Merriam's wild turkeys in Colorado and New Mexico.

Figure: New Mexico wild turkey spring license sales

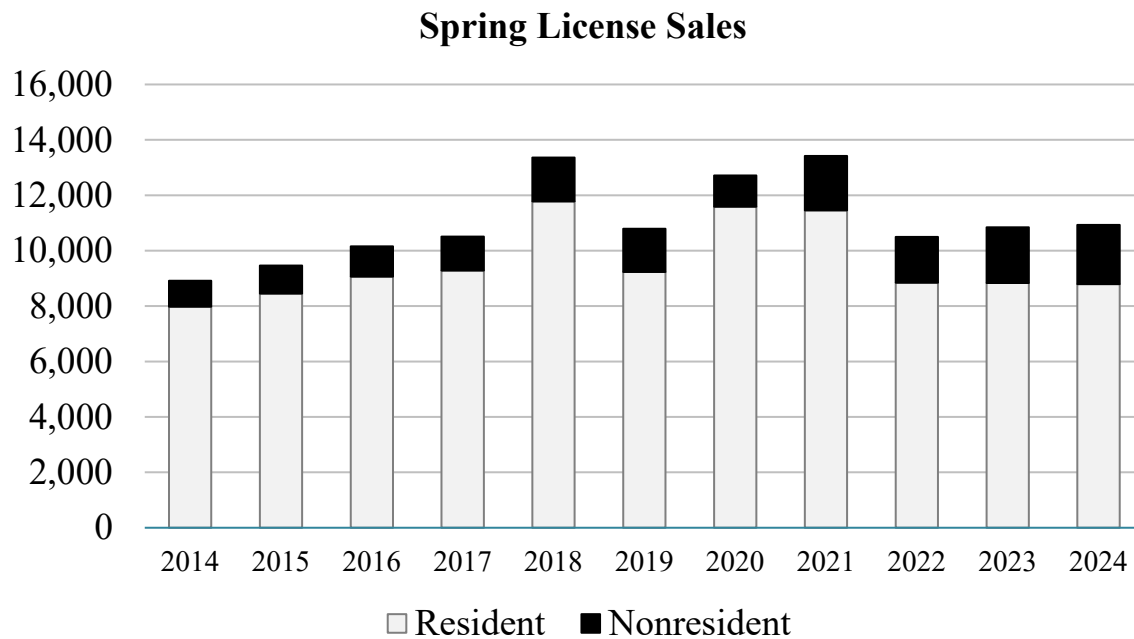


Figure: New Mexico wild turkey fall license sales

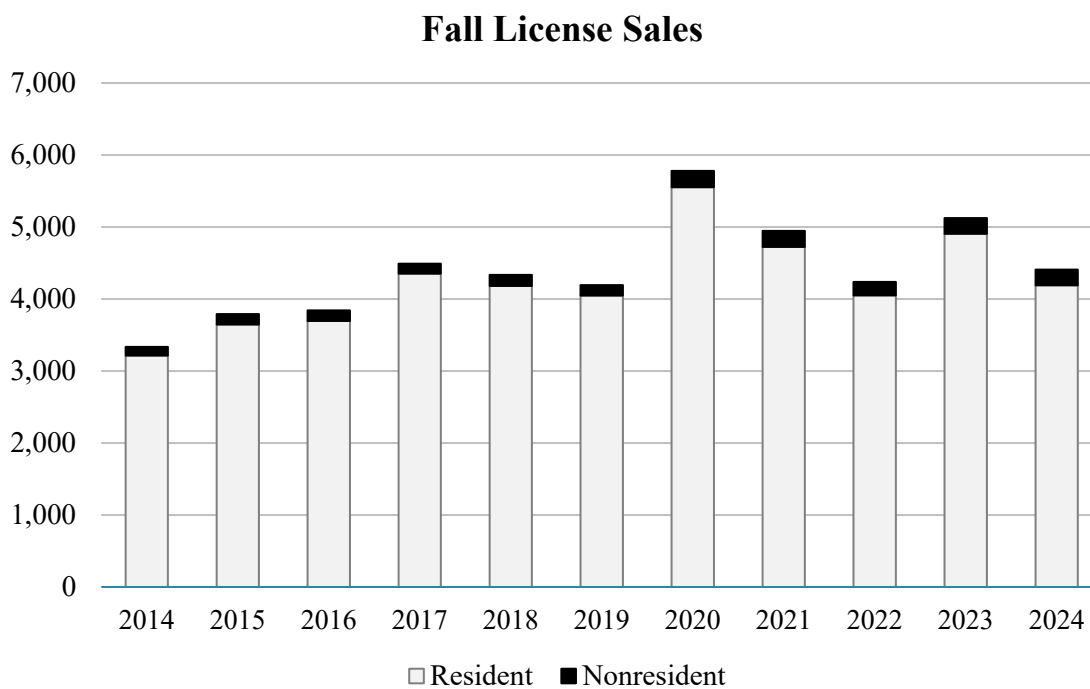


Figure: New Mexico wild turkey spring harvest

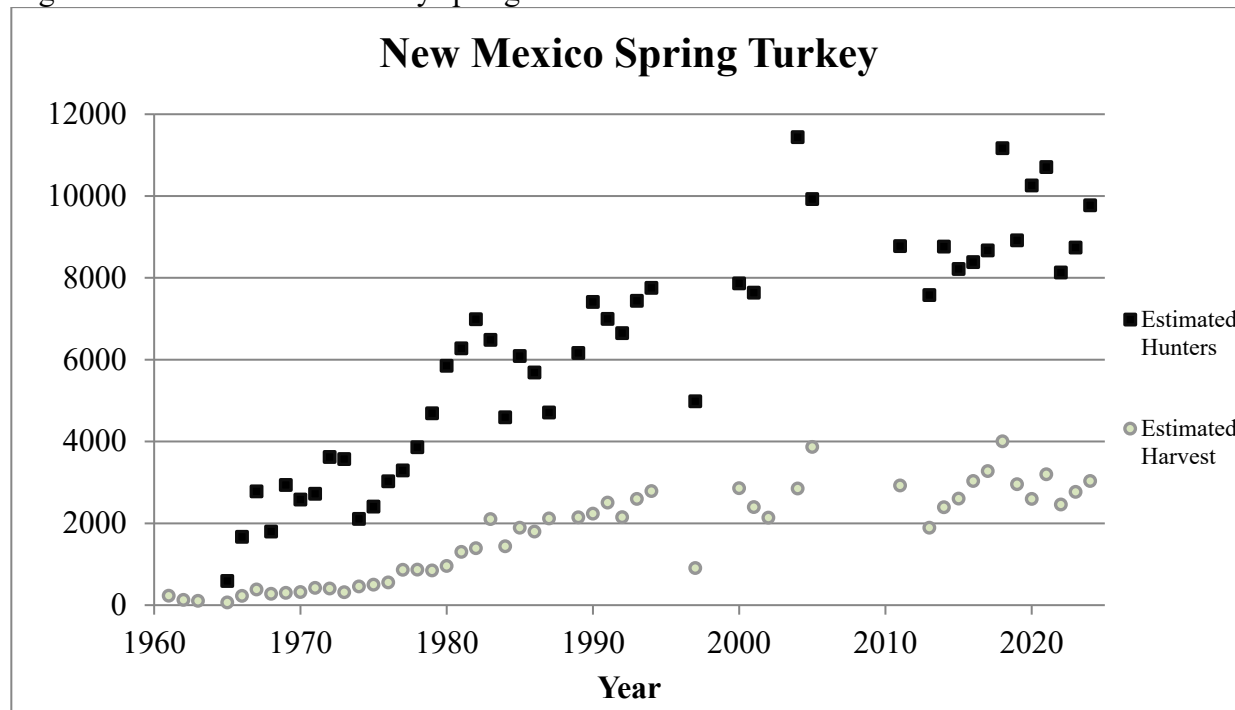


Figure: New Mexico wild turkey fall harvest

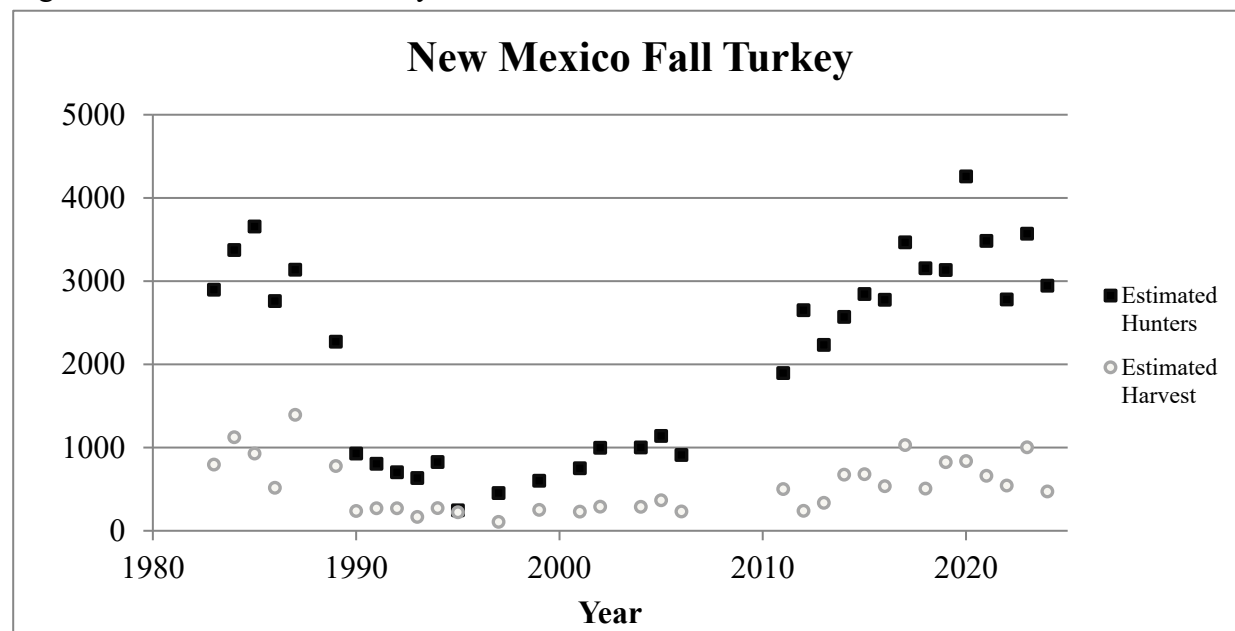

Figure: New Mexico wild turkey fall harvest

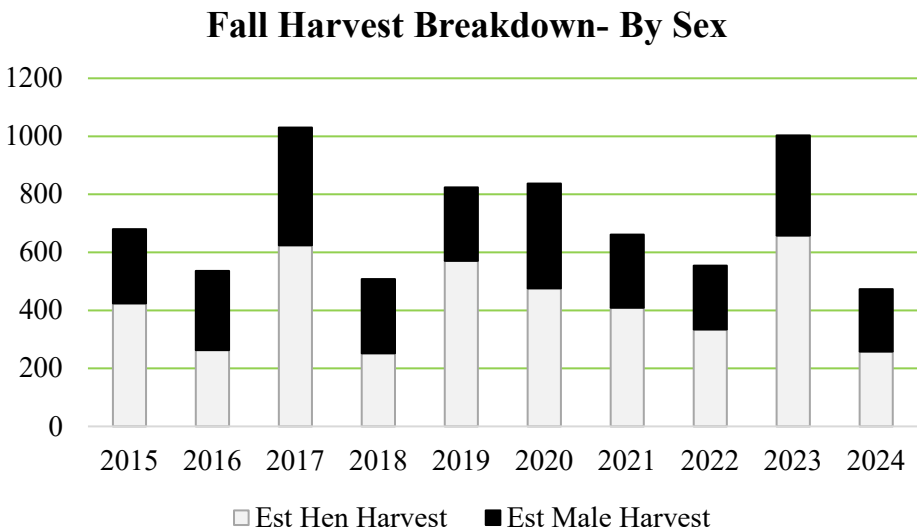

To Whom It May Concern:

I have reviewed the proposed changes as indicated the summary and would make the following comments:

First observation: As a dedicated (resident) spring gobbler hunter with decades of hunting experience here, it is clear to me (and others with long-time experience) that our turkey populations, and especially gobbler numbers, are in a downward trend. Hunting pressure has increased over time, as well as the effectiveness of hunting methods and tools, such that there is no question a larger segment of our gobbler population is being harvested than in the past. This is a concern that needs to be considered and addressed.

I think it is important to consider not only the current status of our turkey population in NM, but also what is happening in the surrounding states, as well as across the country, in terms of changing regulations. Succinctly, many other states in our region in particular, and also throughout the country, are implementing reductions in seasons, bag limits, and nonresident opportunities. It would behoove the Department to take note of what is happening in other states and consider how that could impact hunting pressure and especially nonresident hunter numbers here in New Mexico.

Nonresident hunting : Due to the increasing popularity of turkey hunting (spring hunting in particular), there has been a significant increase in nonresident participation in most states. I think that trend would be demonstrated, as well, in NM. A number of states have set a maximum number of nonresident permits (either issued by drawing or first come/first served). In addition, many states are delaying nonresident hunt dates to allow residents first opportunity to hunt. A number of states also have reduced the bag limit to a single gobbler.

How does that impact New Mexico? By continuing with a two-bird bag limit, NM is becoming more and more attractive to nonresident hunters, resulting in increased nonresident hunting pressure. That trend is bound to increase as more and more surrounding states reduce nonresident opportunity while NM does not. It is time for NM to consider instituting similar nonresident restrictions in terms of setting maximum permit numbers, as well as possibly instituting a one-bird bag limit for nonresidents. Failing to address the potential impact of reductions of nonresident hunting opportunity is surrounding states when contemplating regulations to be implemented in NM is short-sighted.

Recommendations:

1. Season length: the current season structure is acceptable, but if other changes are not implemented in terms of reduced nonresident opportunity (delayed starting dates, reduced bag limit) the season length should possibly be reduced or consideration of the use of stratified seasons (see Wisconsin) might be considered.

2. Nonresident bag limits: At a minimum, the bag limit for nonresidents should be reduced to one gobbler/bearded turkey (in the spring season). Not doing so while other states do this will, without question, increase the influx of nonresident hunters into the state. We are at a point that we need to look at reducing hunting pressure rather than creating a situation where it is likely to increase and increase significantly. Additionally, consideration should be given to delaying the season start date for nonresidents to allow resident hunters the first opportunity to hunt.
3. Resident bag limit: Serious consideration should be given to also reducing the resident bag limit to one gobbler/bearded turkey. I have been a proponent of the two-bird limit, but we are at the point that going back to a one-bird limit should be considered.
4. Fall hunting: Continued monitoring of the impacts of fall, either-sex hunting is imperative. If the apparent downward trend in our turkey numbers continues, it would be wise to reduce the fall season length, or curtail fall hunting of hens altogether, at least in areas of concern. Evaluating fall harvest impacts within management units should be done rather than on a statewide basis.

Please accept the following as the official recommendations of the New Mexico Council of Outfitters and Guides as it relates to the Proposals Under Consideration for Javelina, Turkey, Migratory Bird, and Exotics as of March 19, 2026.

JAVELINA

Support Department's proposed changes as published in the Commission Agenda Meeting Briefing dated March 20, 2026

TURKEY

Generally supportive of the Department's proposed changes as published in the Commission Agenda Meeting Briefing dated March 20, 2026.

NMCOG additionally recommends that the fall turkey hunts, specifically in GMU 6, 10, & 17 become "1 bearded turkey". These hunts are currently either sex. Outfitters in these GMUs have expressed that turkey numbers are noticeably lower compared to previous years. While we recognize that hen harvest is not a large percentage of the overall turkey harvest, eliminating hen harvest is one area where the Dept. has the ability to at least prevent additive mortality.

MIGRATORY BIRD

Generally supportive of the Department's proposed changes as published in the Commission Agenda Meeting Briefing dated March 20, 2026.

NMCOG additionally recommends that the Estancia Valley Sandhill Crane hunts be moved from November 1st to either mid December or January. Over the past several years outfitters report seeing very few to no sandhill cranes in the Estancia Valley during November. However, during late December and January (after the hunt dates have concluded) there are hundreds of cranes in nearly every agricultural field in the Estancia Valley.

EXOTICS

Generally supportive of the Department's proposed changes as published in the Commission Agenda Meeting Briefing dated March 20, 2026.

Oryx

NMCOG Generally supports most of the Department's proposed changes.

We are NOT in favor of increasing the number of off-range Oryx licenses. Outfitters do not agree that the number of public land off-range Oryx is high. We understand that the success rate has increased but we believe this due to an increase in harvest on private lands. Outfitters hunting BLM and State land are seeing very few oryx and it is not uncommon to hunt several days or more without seeing any oryx. The current number of licenses is already bordering on overcrowding in the field. We recommend that the number of off-range Oryx licenses be reduced or at least remain at current levels.

NMCOG additionally recommends that the Department clarify the definition, in Rule, of Broken Horn Oryx. The current definition is confusing and does not clearly specify that Oryx that are completely missing horn(s) would be interpreted as a Broken Horn Oryx. Additionally, NMCOG would recommend the Department eliminate a portion of the second sentence of the definition. That sentence is very hard to understand for most people and causes confusion in the field. Outfitters have indicated that they have failed to allow hunters to harvest obviously broken horn oryx because they are not certain what it means that the "terminal end would not taper to a point for another 25% growth".

It is important to remember that the reason we have a definition of Broken Horn Oryx is because we want to encourage the harvest of these animals. This definition does the opposite by generating confusion that results in outfitters/hunters passing up the chance to harvest a BHO because they are unsure if it meets the definition. NMCOG has spoken with representatives of the White Sands Missile Range and they are supportive of amending the definition. They agree that the current definition causes confusion amongst hunters.

The current definition reads as follows:

“Broken-horned oryx” or “BHO” shall mean an oryx of either sex that possesses at least one horn missing at least twenty-five percent of its normal growth. This may be determined by comparing the broken horn’s length to the remaining horn or where it is readily apparent the terminal end would not taper to a point for another twenty-five percent of growth.

We would recommend that the definition be amended to read something similar to the below suggestion:

“Broken-horned oryx” or “BHO” shall mean an oryx of either sex that possesses at least one horn missing at least twenty-five percent of its normal growth. This may be determined by comparing the broken horn’s length to the remaining horn or if both horns are obviously missing 25% of normal growth. Also to include an oryx of either sex that is missing one or both horns.

Ibex

NMCOG fully supports the Department's decision to dramatically reduce Ibex licenses.

NMCOG has been vocal in expressing concern about the continued decline of the Ibex population for several years. We also understand that the current mortality issue is not a result of hunter harvest. We would like to see the Department allocate additional resources towards helping restore the Ibex population. We would recommend the Dept. consider a more dedicated predator

management emphasis (for both lion and eagle). We have also been notified by outfitters that there are at least 3 water catchment structures in the Florida Mountains (originally installed by the BLM for the benefit of Ibex) and ALL of them are currently non-functional and in disrepair. Perhaps this would be an area where the Dept. might be able to work with the BLM to restore those drinkers.

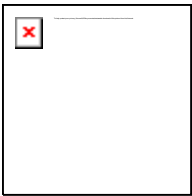

Good afternoon.

I was one of the fortunate hunters who drew a Gould's Turkey tag here in New Mexico last year. What an amazing experience it was! I was able to harvest a mature tom with my bow on the 2nd day of the hunt. I feel truly blessed to have been able to take part in hunting Gould's here in New Mexico. It took great effort and expense for the state to establish a stable huntable population, but I feel it was worth all your efforts. The hunt exceeded my expectations and was an absolute blast. During my hunt, the toms were "henned up" and would not reliably come into calls. The spring winds contributed to that as well. There were opportunities to jump shoot birds several times, but that is not what I wanted out of a once-in-a-lifetime experience. Sitting water proved to be the best option and worked out after a few hours. A hen came in followed by the tom. We got to watch both interact with/attack the decoys before making the shot. My son and brother-in-law were there as well, and we will cherish the memories from this hunt for years to come.

I believe that there are a sufficient number of turkeys to expand the number of tags. In the couple days we were down there, we saw approximately 12 different gobblers on public land and probably 10-15 more on private. Early in the morning, we also heard others gobbling from their roosts both on public and private. The number of birds there was surprising to me, especially considering how dry the conditions were. The ranchers were running far fewer cattle than they normally would because of the drought. Fortunately, they still were pumping water to some of the tanks and drinkers which congregated the birds within a couple miles of available water. I do not have personal knowledge of other years in the bootheel area, but everyone I talked with said that last spring was about as bad as it has ever been.

The biggest issue I see with additional tags is the limited access to huntable areas due to the private land. Much of the public land is effectively cut off from access for hunting. Very few turkey hunters are going to walk in 3 to 5 miles it requires to get around the private land to get to hunting areas. Without better access, additional hunters will be congregated to a few areas. If additional access cannot be obtained, I would look at spreading the tags out by having several different 7 to 10-day hunts.

I would love to see the NMGF figure out a way to get access on or through some of the private land for turkey hunting. As we saw a few weeks ago in Nashville at the NWTF convention, people are willing to spend thousands of dollars to hunt Gould's Turkey and not have to leave the US. Maybe the state can issue a few tags to landowners that they can in turn sell, in return for granting access through their land for additional hunters? If that type of an arrangement could be made, I believe that the state could issue quite a few more tags for the public as there are turkeys now that are not huntable due to being on private and inaccessible public land. This may not be doable, but I would love to see more people get the opportunity to hunt Gould's turkeys as I did this past spring.

Thank you for your work in reestablishing these birds to the landscape of SW New Mexico. I very much appreciate all the NMGF department has done there. Feel free to contact me with any additional questions.

However, approximately the past 5-7 years I have seen a noticeable decrease in the wild turkey population in my area. My driveway, which is dirt and gravel, has often been used as a "turkey" route from the areas across the highway from my property, to the areas west and south of my house. In the past, a common occurrence was to inadvertently encounter many turkeys enroute to somewhere. That no longer happens.

I strongly support closing units with minimal harvest success to either sex fall hunts. In those units with obvious low populations with low success, hunting should be limited to gobbler only spring hunting. I also strongly recommend restricting harvest during spring hunts to gobblers only rather than allowing bearded hens to be shot because of a lack of education regarding identification by hunters. There also seems to be an increasing number of gobblers, at least here in unit 34, the last two years with no visible beards. Under the current rule these birds are not legal to harvest in the spring and if illegally harvested are being mis-reported as immature rather than mature birds. I also strongly support reducing the spring bag limit to 1 gobbler to potentially spread opportunity out over more license holders rather than those of us who have more experience or time to hunt turkeys.

Comments for the Proposed Turkey Rule 2027-2031:

I am voicing my strong objections to the proposed turkey rule as currently proposed. The rule fails to take into consideration the current status of turkey populations and the effects of additive mortality to turkey populations which are declining in New Mexico. Attached is a summary using the Department's data showing the decline in harvest success for 10 hunt units with single digit or no success on the fall hunts. Unit 14 which is not legally open to fall hunting is also represented as hunters continue to report hunting the unit in the fall indicating that the Department has taken no action to rectify the situation. The Department states in their technical information that poult counts show a stable population but this information cannot stand alone as the percentage of hens with poults in a population must also be analyzed in conjunction with this metric to give a true indication of the population trend. 5% of the hen population with 2.21 poults has a very different population impact than 25% of the hen population with 2.21 poults per hen. The Department's current statewide population estimate of 18,500 turkeys represents a significant decline from the estimate just 5 years ago and contradicts the statement of a stable population based on poult counts. The Department monitoring data for Goulds turkeys also shows an approximate 20% decline primarily attributed to drought conditions. This effect is also most likely occurring in Merriams populations which do not have population monitoring ongoing. The Department sold over 15,000 turkey licenses in 2024. No other species has this high of a ratio of licenses sold to an estimated population.

The Department continues to fail to recognize the impact of the loss of tens of thousands of acres of ponderosa pine and mixed conifer forest to stand replacement intensity fires. This is also having an effect on turkey populations particularly in the availability of roost sites on public lands. The current and proposed rule prohibiting take of turkeys on a roost is extremely difficult to enforce. Limiting shooting hours to end at sunset would more likely achieve this objective and simplify law enforcement's ability to enforce the rule. This is already used in neighboring states such as Colorado and used to be the rule for New Mexico.

The neighboring state of Arizona, which is most similar to New Mexico, authorizes turkey hunting only through limited draw hunts. Their population estimate is currently 28,000. They also only have a 3 week spring hunt and a 1 week fall hunt. This contrasts with New Mexico's 2 months of fall hunting and 5 weeks of spring hunting with unlimited licenses. The fall archery hunt should be synchronized with the fall deer and elk hunts to allow for more effective law enforcement efforts. The fall either sex any legal weapon hunt should also be shortened to a two week period. The neighboring state of Texas which has a turkey

population almost 20 times larger than New Mexico's is eliminating either sex harvest for all turkey hunting beginning September 1, 2026 due to population declines. Texas also requires 24 hour harvest reporting for turkeys due to ongoing population declines and the need for better data. The New Mexico spring hunt is also far too long. No monitoring is being done to quantify the percentage of adult male birds being harvested to ensure staying below the recommended maximum harvest level of 30%. Observations in our area of the Southern Sacramentos in unit 34 over the last 9 years show a take of 50-78% of the adult male turkeys every spring. The season length has also resulted in increasing conflicts with private property owners as hunters are unable to find birds on public lands as the hunt goes on. Department data shows that the average hunter is only hunting 3.8 days (2 weekends), a 16-21 day spring season would provide more than adequate time to hunt. The Department currently has a 3 day youth hunt followed by a 31 day general season.

The Department's proposed rule does not address the current situation with turkey populations in New Mexico or the expected impacts on ongoing drought and fires. We need to respect the resource more and be more proactive in our wildlife management. None of the recommendations I have made here would decrease licenses available to the public or significantly decrease the opportunity for public hunting. It would potentially positively impact the resource and simplify regulation enforcement.

Data provided by NMDOW. 2025 harvest data not available. In our area of unit 34 a 25% decline in population was observed from 2025 to 2026. Units with less than 10% success should not have hunts continued in them until population recovery is achieved. Habitat loss due primarily to stand replacement fires and degradation due to drought does not seem to have been considered in the proposed turkey rule.

I wanted to comment on Turkey Rules for the next 4 year cycle (2027 – 2030) and just general rules. I didn't see a specific address for the Turkey comments so just sending here. I listened to the commission meeting on the 9th and heard what has been initially proposed.

Turkey

- I like and am encouraged to hear possibly more Gould's tags coming soon. I hope I get lucky and draw that tag one of these days. I appreciate all the work G&F has done and is still doing to get Gould's off the state endangered list and allowing some tags to residents.
- I have been concerned about the Turkey population, seems like it has been going down pretty much everywhere I've been. I'm still seeing Turkeys, but flock size seem to have gone down in the last 5 years. I have no idea if that is only because of drought or possibly some of the fall hunting that happens. I really would like to see and was encouraged to hear on the meeting possibly going to Gobbler only for the fall. I think that would be a good move state wide for the next 4 years and see how the Turkey populations responds and see what kind of feedback you get from hunters. Another alternative might be having shorter season for ES turkey and then a longer Gobbler only season.
- Last feedback I wanted to give is around the Spring season. I really would like to see something done with over-crowding, especially in the Sacramento mountains. I've been seeing so many hunters lately and especially a huge influx of non-resident hunters. I think either a cap needs to be put on NR licenses or maybe a draw for NR only. The other thing that might help is limiting the tags to 1 gobbler, at least for NR on public land. Honestly, I would like to see it for everyone, residents and NR, 1 Gobbler is plenty for anyone in my opinion and will make the hunting pressure less for everyone.

I also really liked hearing the possible 2 changes for how Private land hunt OTC tags are purchased and the E-TAG purchase change. I think all OTC Private tags for all species should have some kind of private land validation when you buy the tag. I can't tell you how many times I've run into Private land only hunters on public land, especially during Barbary sheep hunts. And the E-Tag/online purchase change totally makes sense. I think it should only be available to purchase before the season starts or at least 24 hours in advance.

1. Summary of Agenda Item

The Department will present proposed changes to the Turkey Rule (19.31.16 NMAC) based on recent survey information, management goals, and public comment.

Proposed amendments focus on:

- Adjust hunt dates based on calendar dates
- Increase up-to permit number for Gould's once-in-a-lifetime hunt in GMU 26 and 27 to 15
- In unit 8, increase permits from 15 to 20
- Conducted analysis of fall hen harvest, and this indicated that there are no units for which low-level harvest will negatively impact the population
- Require the purchase of a license at least one day prior to hunting

2. Background Information

The turkey rule is amended every four years as part of the turkey rule development cycle. The current 4-year rule expires April 1, 2027. Proposed changes to the rule are made based on findings in scientific literature, data collected by Department staff, and public observations and recommendations.

5. Description and Summary of Public Involvement Process and Results

The Department has posted proposed changes to the turkey rule on the Department's website. Input has been gathered from mail and email. Hybrid public meetings were held March 11st in Albuquerque and March 12th in Las Cruces, and a presentation was given at a virtual National Wild Turkey Federation meeting to gather public comments on the proposed changes to the turkey rule.

B. Entry permit hunts: All entry permits shall be valid for any legal sporting arms except turkey hunting in the Sandia ranger district portion of GMU 8. A. The director or their designee may authorize population management hunts for turkey when justified in writing by department personnel.

C. In the event that an applicant is not able to hunt on the dates specified, the applicant's name shall be moved to the bottom of the list and another applicant may be contacted for the hunt.

D. In those instances where a population management hunt is warranted on deeded private lands, the landowner may suggest eligible hunters of their choice by submitting a list of prospective hunters' names to the department for licensing consideration. No more than one-half of the total number of licenses authorized shall be available to landowner-identified hunters. The balance of prospective hunters shall be identified by the department.

A. The director shall collect all proceeds generated through the auction or lottery or both, of not more than two special Gould's turkey enhancement entry permits annually, and such monies shall be deposited into the game protection fund. These monies shall be available for expenditure by the department to be used exclusively for activities, projects and programs aimed at benefitting Gould's turkeys and Gould's turkey habitat, and for costs incurred in carrying out these programs.

B. Requirements for issuance, sale and use of Gould's turkey enhancement permits:

(1) **Issuance:** The director may issue up to two Gould's turkey enhancement entry permits annually.

(2) **Sale:** The auction or lottery or both shall be conducted by an incorporated non-profit organization dedicated to the conservation of wildlife, in cooperation with and overseen by the department.

(3) **Use:**

(a) The successful recipient(s) shall be allotted an authorization for a Gould's turkey enhancement entry permit, which may be transferred through sale, barter, donation or gift to other individuals qualified to obtain a license and hunt. Once an authorization is converted to a permit, the permit will be non-transferable.

(b) Individuals hunting pursuant to a Gould's turkey enhancement entry permit must obtain and have in their possession a valid turkey hunting license and any other stamps, tags or permits required by rule.

(c) Unless their hunting privileges have been revoked pursuant to law, any person is eligible to bid on and purchase a Gould's turkey enhancement entry permit.

(d) Individuals holding a Gould's turkey enhancement entry permit shall not be prohibited from hunting other subspecies of turkeys in New Mexico as allowed in 19.31.16 NMAC.

(e) The entry permit shall be valid for any legal sporting arms, and the bag limit shall be one bearded Gould's turkey.

(f) The season dates for each entry permit shall be no more than 30 consecutive days between April 1 and May 31 as specified by the entry permit each license year.

(g) The harvest of one bearded Gould's turkey shall count against the license holder's spring turkey bag limit.

(h) The hunt area for each entry permit shall be any legally accessible public lands in GMUs 26 and 27 where hunting is allowed, and private land with written permission.

(i) Gould's turkey enhancement entry permits granted through auction or lottery, as described above, shall not be considered 'once-in-a-lifetime' permits.
